The owner and/or contractor are responsible for requesting an inspection before covering or concealing any work and shall inform the City of Elyria of any exposed cross connections. Failure to comply may result in legal action by the City of Elyria.

The undersigned hereby certifies that the information contained herein is accurate to the best of his/her knowledge. The undersigned owner or owner's agent, by commencing or authorizing commencement of work, takes full responsibility for compliance with City, State, and Federal codes relative to discharge of "clean" water to a sanitary sewer or combination sewer system.
