- 1. Jim Jablonski, 806 Sherwood Dr., Elyria is here representing Lester Lynch who is an Elyria High Alumnus who has gone on to become an internationally known opera singer. He is an Elyria High School graduate which is where he got his early training from and went on to Baldwin Wallace and moved on to well known music conservatories on the East Coast. Mr. Jablonski came to know Lester a few years ago while he was writing a book about the history of Elyria. He interviewed Lester and thought it was a great story of a young African American student of a working class background who credits the Elyria Schools who started him on his path to stardom. Mr. Jablonski suggested that Lester come back to the High School and work with some of the music students and then put on a performance for the community. And Lester loved the idea and he will be giving talks at the school and will be giving a performance on Thursday evening at the High School Performing Arts Center. Mr. Jablonski said that he and Council person Madison had called Lester and Marcus will be able to add more information. Ms. Green is the Vice President for Strategic and Institutional Development at LCCC and is here this evening to represent LCCC and the upcoming Issue 17. President Dr. Marcia Ballinger wasn't able to attend. They take great pride in delivering quality and excellence in higher education for the community and to partner with the City of Elyria in doing that. In 2018, LCCC was the 1st Community College in the State of Ohio to become authorized to have a change in Charter to deliver their own applied Bachelors's Degree in area of Micro Electronic Manufacturing. The Community comes first and they have made a difference to the Community. They have now added 'Achieving The Dream' for excellence in student success to ensure academic and career success for all students.
