Police Chief Whitely: Police Chief Whitely stated that he did not have a report but was asked by two people about the usage of the drones. Mr. Oswald stated that they spent a lot of money on those drones. Chief Whitely state that the drones were purchased by Water Pumping for water tower inspections, five (5) towers and a cost of \$50,000.00. They can use the drones for 15 to 20 different things and they were paid off 18 months ago. They can be used for missing people, etc. They used them at a serious accident scene that would have blocked traffic for at least 2 hours using the wheel to measure everything, the drone did it in 3 minutes. The fire department can use them for finding hot spots and the Building Department can use them for checking out taller buildings in the City. Mr. Oswald asked what happens if they fall from the sky and break? Chief Whitely stated that they had this happen and it was covered under warranty and they are talking with the company about a maintenance agreement. Mr. Tollett asked if the fire department has used them in house fires for firefighter protection? No, they have not at this point in time. Mr. Callahan asked if the City was the first in the County to obtain them? Chief Whitely's comment was not heard; the Sheriff Department has them but they do want to look at the City's.
