1. CALL TO ORDER:

The regular meeting of Elyria City Council was called to order on Monday, April 19, 2021 at 7:00 P.M. by President Stewart. President Stewart opened the meeting with a moment of reflection and followed by the Pledge of Allegiance. Virtual Council meeting. 5. REMARKS AND REPORTS OF CITY OFFICIALS:

Council President Stewart: None

Mayor Whitfield:

The Mayor thanked the residents that participated in the Week of Engagement. He shared that a lot of dialogue was held. Interesting opinions and ideas that people have were learned. The Mayor thanked Windstream for their donation of thirty-thousand dollars to help with computer training for Elyria residents. He also encouraged residents to take advantage of the opportunity that is available. Information is available at elyriacares.com. Trainings will be available all around town. He provided information for the upcoming Pride/Service day, May 15th, that will include a bike drive. A city internal committee has been established to include: Engineering, Community Development, Street Department and Communications to review infrastructure projects and the American Rescue Plan. The committee will present a list of infrastructure projects in the near future.

5. REMARKS AND REPORTS OF CITY OFFICIALS: CONTINUED Safety Service Director Brubaker:

SSD Brubaker provided information regarding an email previously submitted for First Energy fall tree trimming. Most of the streets that will be impacted are in the township or near the mall or near Gall Ave. The First Energy Representative has been invited to the August council meeting. The other item was the potential for snow this week. The Director says that we will be ready for the snowfall.

Finance Director Pileski: No Report

Law Director Deery:

Requested Executive session for later in the evening to discuss imminent litigation. The other topic, is the Mayor and his Administration will wish to discuss economic development. Law Director Deery requested that Attorney Geoffrey Smith representing his client, Gihad Zayed of 824 Middle Ave, Elyria, Speedy Gas to provide a short presentation and information regarding the liquor license request for the address. Law Director Deery yielded the remainder of her time for Attorney Smith and Mr. Zayed.

Geoffrey Smith, 124 Middle Ave. Suite 800, Elyria, OH, representing Gihad Zayed of 14027 Lakewood Heights Blvd., Cleveland, OH.

Mr. Smith explains that Mr. Zayed purchased the property, however he is not related to the previous owners. He understands that there is some bad history, however his client is looking to renovate the property similar to owned properties throughout the Cleveland area. Pictures are being circulated. He plans on running a good ship according to Attorney Smith, with operating hours of six a.m. to twelve a.m. He will provide a well lit property. Attorney Smith added that now and in the future, he, Mr. Zayed and Mr. Zayed's father will always be available to answer any questions.

Mr. Zayed explained that the property was purchased and significant renovations have been made to it. The plans are to make sure that it is properly staffed. He understands that right now it is an eyesore to the community, however he plans to beautify it. He says that it is a significant investment. He like the area and has been establishing relationships in the area. He stated that his accountant is Jay Tokar, Geoff Smith is his Attorney. Mr. Zayed says that he has witnessed the work put into Middle Ave., he would like to be a part of the project. Mr. Zayed stated that he has been working with City of Elyria Building Official Darryl Farkas to get permits and plans for the building. The plans are to create a new building with the exception of three walls, new lights, pumps, parking lot, extension and fresh food service. He intends to make the business an asset to the community. Mr. Stewart shared that pictures of other properties owned and restored by Mr. Zayed were being circulated for council members to view. Mrs. Mitchell thanked Mr. Zayed for the beautification of the area, however shared that the feelings regarding a really bad reputation of the gas station, that precedes him and it is not personal towards him or his family, however that is the reason council is hesitant in this decision. Council is mindful of the young lady that was killed at that location, and does not want the same type of activity and she is also concerned about the proximity of the school. Mr. Tollett referred his question to Police Chief Whitely,

asking him to please share his thoughts. Chief Whitely, said that under the previous owners that owned the establishment when the young lady was killed, there was no cooperation at all. He stated that EPD were ignored when they visited. Chief Whitely stated that he does have some fears of that happening again. He did confirm he does not know the current owners or anything about their other businesses. He can't say if they would be the same as the previous owners, he does not know that. Mr. Zayed was questioned about the location of his other businesses. He responded his businesses are located throughout East Cleveland and outside of Cleveland. They have taken over places that have had loiterers and shootings over the past thirty-eight years, however they have never had a shooting. They do not allow loitering outside of their business. He explained that they install on their stations thirty two channel high definition cameras with ip and license plate cameras. He offered city council and Elyria Police access to the cameras at any time. Mr. Zayed stated that his preference would be if the outside cameras were connected to the Elyria Police Department. He says that him and his family is here to grow a successful business and grow their name. Their name means a lot to them, it's not about a quick buck. They would like to be a part of the community. He stated this may be their first business in the community, however they do not want it to be their last business in Elyria. They want more businesses in Elyria. They want to employ people of Elyria. He expressed to Mrs. Mitchell that they sponsor the high school teams. They have a food program and plan to be an asset to the community and not a detriment. Mr. Zayed says he is accessible twenty four hours by phone. Mr. Stewart asked if there is any relation to Mr. Zayed and the previous owner, in which Mr. Zayed responded no. Mr. Cerra referred a question to LD Deery, "How does a hearing like this work and what takes place?" LD Deery, explained that most likely by zoom a meeting with the Ohio Liquor Control Commission would be held. She shared that even in pr-pandemic times, the meetings were held virtually. The city would present evidence as to why we are opposing the liquor license application. The applicant would present their case for why they believe they are entitled and deserving or eligible to obtain a liquor license. The officer on behalf of the commission would make a decision. Bear in mind, liquor control will also complete it's own due diligence investigation as far as the proximity of the property to a school, is it located in a dry area. These types of circumstances are taken into consideration prior to the license being issued, independent of the city raining the issues. Mr. Farkas provided information that the information provided by the ownership has indicated a great improvement from what is currently there. The new owners do have plans for some aesthetic appeal regards to shrubbery, fencing, nice decor and an inclusion of an addition. Mr. Farkas reinforced what Attorney Smith and Mr. Zayed previously stated that the owners will be making quite a great impact to the area, more so than what is already there. Mr. Farkas is working with the review process and they are very close to granting an issuance for this project. Mrs. Simmons stated that council has some resistance and shared with Mr. Zayed that he needs to mindful that the do not want this situation to happen again. Mr. Zayed expressed his understanding and explained that he is not related to the previous owners. The previous owners were tenants, he is an owner and purchased the property from the landowner. His business groups owns and operates ten other liquor permits. He is a business person, he will check identifications and doesn't anticipate having any issues. Mr. Stewart expressed that he appreciated the open door policy and transparency and openness to the City of

Elyria Police Department compliance. Council would like to see that area of town flourish as well. Mrs. Davis stated that she is glad that the property was purchased and shared that owners versus tenants exemplify a sense of pride. Mr. Zayed reiterated that an extravagant amount of money is going into the property. Mr. Baird shared that he was impressed bay all that was shared, the pictures of the other locations are impressive and that he is glad local relations are being fostered, like with Mr. Smith, a reputable person. That does provide a lot of confidence. Mr. Baird acknowledges the investment made in the property. Mr. Baird expressed his belief that the business owner is in control, you can't control people, however if things aren't right, police it quickly. Mr. Baird expressed he was in support of not having a hearing.

Police Chief Whitely: No report

Fire Chief Mack:

Fire Chief Mack presented along with Assistant Chief Norris. He shared that today two individuals were promoted: Mr. Joseph Vargo was promoted from lieutenant to captain and Mr. Frank Ruffo was promoted from firefighter to lieutenant. There was a pending vacancy, EFD (Elyria Fire Department) had to wait for test results before the promotions could be confirmed. The Chief extended congratulations to both individuals.

The Chief reported on an appartus plan/strategic planning - EXHIBIT "A"

ASSD Calvert:

ASSD Calvert provided an update on the Community Development Corporation. April 15, 2021 a virtual information session was held, the turnout was great. The event had good representation and good questions were presented. Today the committee held a walking tour of downtown Elyria. Several members that make up the CDC(Community Development Corporation) walked and viewed the buildings downtown, surveyed the condition of the buildings and redevelopment opportunities. They had the opportunity to meet some of the building owners, as well as learn of some of the history of the downtown area and get excited about the future. ASSD Calvert extended an invitation, that if you haven't already participated with the CDC, there are several committees that you are welcome to get involved with, even for informational purposes. The invitation is extended to the general community. LD Deery asked if there was a time line for establishing an incorporation for the CDC or becoming a 501c3? ASSD Calvert responded that the CDC is in the process of establishing themselves as a non-profit. They have named themselves Elyria Community Partnership, are looking at logos, working on events, looking at the needs of the city and where they can fill in the gaps and anticipate by summer they will be fully incorporated.

Engr. Schneider:

No report, Eng. Schneider submitted a referral request for the 2021 Emergency Sanitary Storm Sewer Repairs. Mr. Oswald had a question about an update to East Broad St. design project? Mr. Schneider explained that federal authorization of the contract has to be confirmed through ODOT (Ohio Department of Transportation), the process takes a while. Authorization was received last week. Data collection will start over the next couple of weeks. Handouts will be submitted to all adjoining property owners notifying them of the project and details of what they can expect of the project.
