Notice is hereby given that copies of the proposed TAX BUDGET (estimated unencumbered balances, estimated revenues and estimated expenditures) of the City of Elyria, County of Lorain, State of Ohio, for the calendar (fiscal) year of 2022 will be on file beginning Friday, June 25th, 2021 in the offices of the City Finance Director and the Clerk of Council, and will be available for public inspection by contacting the Finance or the Council Offices, pursuant to the requirement of law. The proposed Tax Budget indicates the estimated revenues, estimated unencumbered balances and estimated expenditures for the year 2022.

President Stewart asked if there were any proponents:

Proponent one: Elyria Finance Director Ted Pileski explained that this is the 2022 Tax Budget. The City is required by The Ohio Revised Code to prepare and submit this budget to the County Budget Commission in July of the prior year. What this documents does is we start with estimating what cash balances will be at the end of the current year and the beginning of the next year by 'fund group'. And then by estimating revenues and expenditures for 2022. And then coming up with a final cash balance at the end of 2022. This document becomes the City's starting point for the certificate of estimated resources, which is the document that allows Council to appropriate monies next year.

At the end of this year this certificate of estimated resources will be amended to replace the estimated beginning cash with the actual cash figures. It will also be amended for any changes that there might be, as far as revenues that might come in during 2022 and then that document becomes a working document through the course of the 2022 as far as estimated revenues and how much can be appropriated by fund group. There are two particular items in this tax budget. One is the Rescue Plan Money, we're scheduled to receive another nine million plus and that's incorporated into this document. The second thing is the loss of Bendix. The normal revenue estimate had to be reduced for income tax revenues by 1.5 million in withholdings plus an amount for tax on net profits, which can't be disclosed.

Upon Council's approval, this will be submitted to the Lorain County Budget Commission.

And at the end of the year it will be amended for actual cash figures.
