# 5. REMARKS AND REPORTS OF CITY OFFICIALS:

Mayor Whitfield: A couple of highlights that what were pointed out from the busy weekend of community groups that included Lorain County Health & Dentistry Covid testing. Love Elyrians gave away one hundred free meals at a new restaurant South Side Eats, The Urban League hosted a Census event at South Park, Goodwill Technology drive. If there are any Seniors looking for computer classes or anyone looking for computer training and a device, should visit the website: elyriacare.com. Good Knights of Lorain County, assembled and delivered one hundred beds to families of Wilkes Villa. Mayor posed the question to "Parks People", what do we want? We all want the parks full. How do we go about getting there, is up to him and his team. They are figuring it out. It hasn't been easy, but they have met the challenge.

Safety Service Director Feuerstein: Expressed communications were had with the Ice Hockey Club, wanted to update council that the rink will be up and running for high schools, as well as planing for a open skate. Also met with the Parks employees to ensure everyone's safety and get their feedback. One additional walk through is planned to confirm safety and a benchmark for the other facilities. Also, as the Mayor and President Stewart said to get back to some sort of normalcy. President Stewart addressed the Parks board meeting that was held regarding contracts for leasing the buildings. The issue will need to reviewed by the Law Director's office, the administration and the Parks Board for groups who want to use the facilities. Want to ensure that we are all on the same page.

# 5. REMARKS AND REPORTS OF CITY OFFICIALS: CONTINUED

<u>Chief Whitely:</u> The past week Elyria Police Officers were awarded for types of calls they handle. The article was in the Chronicle Telegram. In addition, wanted to express appreciation for the work the officers do every day.

Assistant Dir.Calvert: Provided an update on the status of the Cares Act small business grant program to date, the Elyria Economic Development Committee has approved thirteen applications, deferred four for further information and in six in process that currently that will be reviewed. In total there is \$696.00 in request for funding. Some of the expenses will not be eligible. How much is fundable will be determined. Details of the grant agreement and required documentation are still being reviewed. No awardees have been notified.

Assistant Dir Brubaker: Provided an update on the ice rink protocols. A meeting was held with Mr. Horwedel and several of the employees of the Parks and Rec department, along with Mr. Schneider on how we will provide access to people coming in and out of the facilities. Particularly what the rules and regulations will be with the open skate. We will have to reduce the number of Friday night participants. The number of participants will be confirmed by the administration and Lorain County Public Health Department. The Friday open skate target date for opening is November and additional program offerings will expand from there. Discussion was held with Mr. Farrell and the mayor regarding money available in the vehicle purchase allocation. Details will be submitted by Mr. Farrell indicating te changes to some vehicles. Question posed from Mrs. Mitchell, "When we allow these groups to use the facilities, will a staff member be on site during the entire time they're there at the ice rink? ASSD Brubaker responded, yes, staff will be present.

# 7. PETITIONS-COUNCIL MEMBERS:

Mark Jessie: (attached)

<u>Donna Mitchell:</u> Stated that it is important to know that Community block grant money is coming up. The Parks and Recreation Dept. always has money for their funded for their senior and youth programs. If nobody is in that role that is aware of the funding opportunities that are available, what they need and should be doing. Then we're missing out on federal tax dollars that we should be using to help our parks. So that is another reason we need a Parks Director, because that money is available, hover without proper staff, we can't apply for it.

<u>Judy Keys</u>: Expressed the same sentiments of Councilman Jessie and Councilwoman Mitchell. She stated that our safety service directors are currently being asked to take on another role in overseeing and managing our Parks & Rec. Program. Mrs. Key expressed that there are plenty of issues in her ward alone to keep the safety service forces busy full time. She stated what an amazing job they do, however she believes that it is asking a lot to ask the Parks department to oversee programs. She along with her colleagues and constituents is committed to brining back Parks Director Carrie Reardon to oversee our Parks & Rec.

Mr. Tollett: Addressed his remarks directly to the Mayor. He stated that his family began working for the Parks department the year of the flood of 1969. His father hired former parks director, Frank Gustoff, his sisters worked for the park and he has a family history with the parks, himself included. He provides an interesting observance of him showing up for the rally for the hockey team, they had a complete action plan for covid and were way ahead of the game. Mr. Tollett expressed that his concern is all of the leagues, all of the senior programs, all of the youth programming need to have that same type of action incorporated. To have an action plan established in an appropriate way, requires a director that is specific to that function. Mr. Tollett asked Mayor Whitfield to please consider hiring back Mrs. Reardon.

Mr. Oswald: Expressed concerns with the water (flooding) issue. He stated that he is the fourth ward councilman and he is the person that has been in that area watching these residents cry trying to pump water out of their basements. Mr. Oswald provided the example of how bad the flooding is, that during his campaigning, he could not get to some of the houses, because the water was overflowing in the sidewalks just from regular rain. He confirmed that the residents have lived with the situation like this for quite some time. Every year promises have been made to address the flooding, Mr. Oswald suggested to council that they pass something. People are trying to stay afloat and spending money on this year after year. They can't get insurance and the situation is impacting too many people.



As requested, this is Karen Sims recapping the concerns voiced at the subject meeting.

I am concerned about the flooding in my neighborhood as it continues to worsen. I have lived at 203 Fullerton Road, Elyria, Ohio, for 36 years and have done everything within my power to correct the flooding. My crawl space has been flooding over the last several years which is of major concern as I have a furnace there. I spent well over \$10,000 a couple of years ago to replace broken drain tile around my house, including under my cement driveway, as well as a new sump pump with an additional back-up battery-operated sump pump, then had to repair the damage done to the driveway. Even after all of this, the flooding of the crawl space continues. I have done all I can do to ensure the safety of my home and maintain the property value of my home for myself and the city as well. I now expect the City of Elyria to take the steps necessary to remedy this neighborhood situation.

Additionally, my neighbor, Nancy Captain (205 Fullerton Road, Elyria, Ohio), asked if I could help her by adding her stated remarks to my email. She, too, has a house in peril due to flooding. During the most recent period of rain she had 10 or 11 inches of water in her basement. On 9/21/2020 she had to have a furnace repairman come to her home to fix her furnace and was told the damage was due to the flooding.

Please help us! We are relying on City Council to vote to take action on this! The ball is in your court!
