RESOLUTIONS

1. **RESOLUTION NO 2021-**
A RESOLUTION DESIGNATING FIFTH THIRD BANK AND HUNTINGTON NATIONAL BANK, AS PUBLIC DEPOSITORIES, ELIGIBLE TO RECEIVE AND ACCEPT ACTIVE, INACTIVE, AND INTERIM FUNDS FOR DEPOSIT, SUBJECT TO THE PROVISIONS OF SECTION 135 OF THE OHIO REVISED CODE, FOR A FIVE (5) YEAR PERIOD BEGINNING DECEMBER 1, 2021 AND ENDING NOVEMBER 30, 2026, AND AUTHORIZING THE FINANCE DIRECTOR TO ENTER INTO AN AGREEMENT FOR THE DEPOSIT OF ACTIVE, INACTIVE, AND INTERIM FUNDS WITH SAID PUBLIC DEPOSITORIES.

2. **RESOLUTION NO 2021-**
A RESOLUTION FINDING THAT THE CITY HAS UNFIT FOR CITY OF ELYRIA MUNICIPAL USE CERTAIN CITY PROPERTY.
