My wife, Maria, and I were here five months ago regarding loud music from the Dawg House Bar on Antioch Drive near LCCC. Since that time not much has changed.

When there's a live band on Friday, the music starts around 8pm. We hear the "thump thump thump" of the bass in our house. The next song is different, and we hear "thumpa thumpa thumpa". A smoker opens the patio door and the music is twice as loud. Same when they go back in. When the band takes a break, it's quiet again, and we think that maybe they're stopping at a decent hour. But it starts back and goes until midnight, sometimes 1am, sometimes longer. The patrons leave and start their own music in their "boom cars". Then there's drag racing and "donuts" on Antioch. We know all this because we're still awake. And then it's Saturday night, or the Wednesday before Thanksgiving, and it starts again.

So when we call the police, the dispatcher asks if we just want to make a complaint, or if we want an officer to stop by. Then she says that the music isn't too loud anyway. But everyone tells us to keep calling the police, and keep a record of all of the calls. We're not sure why.

We've tried to get a clarification of the city's ordinance for "noise disturbances", but we can't seem to get to the right department. Our house is more than 100 feet from the Dawg House. They received a warning back in May, but no citations that we know of.

Ironically, I play in a rock-and-roll band. When we play at places like the Veranda in Avon, which is in a residential area, we're done at 9pm. When we play at campgrounds in Port Clinton, we're done at 9pm. When I play solo at Unplugged Brewery, I'm done at 9pm. The places that we play late, like the Hooley House in Westlake, are not in residential areas, and they're not buildings with glass fronts and nothing inside to contain the sound.

When we had the house built in 2018 we knew that there were businesses around, such as a restaurant, bank, dentists, Kindercare, a Veteran's organization and the college. But we certainly didn't expect to have to listen to someone else's music nearly every weekend.

We mentioned five months ago that we were second-guessing our decision to build where we did in Elyria. We'll be looking for a "for sale" sign soon.

Good Evening Council members, I'm Melissa Sabine, a resident at Twin Lakes Homes in Elyria. I will be sharing a letter from my neighbor, Linda Dull. Linda is legally deaf and only reads lips, therefore, she's asked me to share her story with you today.

December 6, 2021

My name is Linda Dull. I moved to Twin Lakes in 2017 with excitement and hope. I had to leave my current home in Marsh's Landing in Elyria as it was taken over by a new private owner and it became unaffordable on my fixed monthly income. The new owners implemented a \$45 monthly increase in rent as well as the ceasing of my \$35 senior discount. So, I had to begin looking for a new home.

I had a small amount of funds set aside which would allow me to purchase a dwelling in Twin Lakes and then use my monthly Social Security to afford the \$350 monthly lot rent as well as my utilities, gas, groceries and medications, making ends meet on a fixed income. I had friends who lived in Twin Lakes, so I knew how much they liked it and the affordability it provided to them on fixed incomes as well. It was a known community, family owned and had a great reputation. It had 24/7 security and all new residents had a background check before being approved to buy and live here. Being a park for seniors, 55 and up, I felt safe and secure.

With the sale of the once family owned park to an investor group for the 1st time about 2 years ago, things have changed. Some changes were to our services, like we no longer have Security, which as a 72 year old woman, I no longer feel as safe. Even more so, and why I am speaking to you today, is the seemingly consistent and rapid rent increases imposed by Legacy since the first purchase and after the 2nd most recent investor group purchase. My lot rent has increased to \$428 so far, with another increase coming in 2022! For new residents coming in, the rent is now \$725 (in addition to the cost of the home)!! How is this predatory pricing acceptable? As seniors on fixed incomes, many of us, including myself, may have to leave our homes. And who can we sell to with a lot rent that is almost 30% higher than the average for parks like ours in Ohio, with more services and amenities!

I moved here because I could no longer afford to rent elsewhere. Now, I own home but rent the lot. However, I'm being priced out of my home due to the rent increases and unscrupulous business practices of Legacy. I will soon be choosing between food and medicine versus lot rent. How can this be ok? What will happen to me and my friends and neighbors as these investor group purchases and rent increases continue?

I hope that you will consider my plight, and understand that it is one of many of the same stories of the residents of Twin Lakes Homes. Thank you for your consideration and time in assisting us in stopping these predatory practices.
