1. CALL TO ORDER:

The regular meeting of Elyria City Council was called to order on Monday February 7, 2022 at 7:04 P.M. by President Stewart. President Stewart opened the meeting with a moment of reflection and followed by the Pledge of Allegiance led by Mr. Oswald.

5. REMARKS AND REPORTS OF CITY OFFICIALS:

Council President Stewart: None

Mayor Whitfield:

Mayor Whitfield provided a presentation to city council. Mayor Whitfield also provided his appreciation to the street department for the outstanding work provided during the recent inclement weather.

Mr. Tollett commented that the presentation was outstanding, he followed up on the misinformation that is being spread brought up by Mayor Whitfield and expressed that it is important for council to protect issue six and what it stands for. He believes it is the consensus of all of council to protect issue six, what it stands for and how it is used. What has to made clear to residents is that street will get paved annually.

Ms. Mitchell thanked the Mayor for providing the information to council. Ms. Mitchell's concern was the representation in the survey of 370 respondents out of a city population of 57,000, she expressed that was not a very good representation. Ms. Mitchell provided the remaining time left of issue six, in that the city is currently in year two of five years, only three years are remaining. In addition, if issue six is not used in the capacity that it was promised to residents, it may never

get passed again. If issue six doesn't pass again, the risk is no new trucks or streets. She expressed that it is vitally important that issue six is protected.

President Stewart thanked Mayor Whitfield for his presentation. He provided additional information that another ½ percent income tax will be presented in 2023 that has been on the books for 35 years. Finance Director Pileski confirmed since 1984. The ½ percent tax will mature June 30, 2024.

Mr. Lipian commented that he appreciated the historical data in the presentation. Mr. Lipian believes that small poll sampling provides a voice of the people and thanked the Mayor for his work.

Mayor Whitfield closed with final comments to say, overall engagement and response is to develop the Midway Mall and Downtown areas.

Safety Service Director Brubaker:

SSD Brubaker provided an update from the previous week snow storm. SSD Brubaker echoed the Mayor and provided kudos to city employees who were out plowing. He shared that not just AFSCME employees worked during the storm, Chapter 165, building department inspectors, engineers were all out plowing snow. Thursday morning things looked well, however around 10:00 a.m., the snow was non-stop for the next 24 hours and difficult to keep up the pace. The number of motor vehicle accidents from Wednesday at 6:00 p.m. through Friday at 8:00 p.m. with injuries was 0, without injuries was 8. One of the accidents was two city plow trucks. Eight vehicles were towed due to the parking ban. Three thousand tons of salt was used., equivalent of \$71 a ton. Five hundred and eight man hours were calculated during the time period. Secondary routes were plowed twice. Seven hundred, four man hours were calculated in small trucks working the secondary streets. Four areas need some additional clean-up of the streets. The wastewater department worked on the North side of town with some clean-up areas. Overall, the employees did their very best with the challenges of blowing snow, etc. Drivers were being trained and rotated every 12 hours. The end result was a huge accomplishment.

President Stewart expressed that the city employees did a phenomenal job, especially to have inexperienced employees learn to work a plow truck with no injuries. President Stewart had a question regarding parked cars on streets, where streets are in need of plowing. SSD Brubaker, responded that EPD could mark parked vehicles for 72 hours, however he did not believe the vehicles could be ticketed.

Mr. Oswald expressed that the employees did a great job. He expressed that his ward has a lot of cul-de-sacs and it is difficult to plow if cars are on the streets. He pleaded to please keep cars off the streets to make room for the snow plows.

Mr. Lipian provided kudos to SSD Brubaker for his coordination and the great job of all city workers.
