Mayor Whitfield:

Mayor Whitfield thanked everyone for attending the Special Council meeting that was scheduled on March 28th. Police Chief Pelko:

Chief Pelko reported that Lieutenant Welsh graduated from the FBI National Academy, a ten week course in Quantico, Virginia. April 6, 2022 the Elyria Police Department was scheduled to host a "Welcome to the Police Department" lateral transfer from 5-7 PM. Mr. Cerra asked if this was the first time the police department has ever hosted an event such as this. Chief Pelko was not certain, however stated that he could not recall and was making an effort to entice experienced officers. Mr. Cerra inquired if pre-registration is required. Chief Pelko shared at the time of the meeting, three individuals were registered to attend the open house.

Fire Chief Pronesti:

Chief Pronesti reported that two job offers were extended to firefighters through the lateral transfer program. The two new firefighters will begin employment in April. The two firefighters are the last two of eleven to be hired with the Elyria Fire Department that was approved through ARPA funding. The goal with the additional workforce is to decrease overtime, that should be reflected once the new employees are on-boarded and trained. Chief Pronesti shared that a new process for hydrant flushing is being implemented. The hydrants will be flushed by wards, starting with ward one. Information will be disseminated.

Superintendent Korzan:

Superintendent Korzan provided information regarding a supply chain issue that impacts agenda item #11. There was an ordinance, 2022-29 that passed in February 2022, the WWPC Plant was going to purchase a 2022 mac semi-tractor. However due to supply chain issues the vehicle can not be secured. The request is to amend the ordinance, to not be model specific and request a more generic vehicle model for purchase.

Mr. Oswald asked if an explanation could please be provided as to why the manhole cover is unable to be repaired on the corner of Depot St. Mr. Korzan explained that it is not an easy repair, however they are working on it and will get it taken care of. Mr. Tollett asked if an explanation could please be provided for what happens in resident's homes during hydrant flushing in reference to water supply. SSD Brubaker explained that during that during the hydrant flushing process, water in resident's homes can come through the pipes rusty temporarily. If water discoloration is experienced, residents are encouraged to run the water until it turns clear. There is no contamination or reason to be concerned.
