The regular meeting of Elyria City Council was called to order on Monday April 18, 2022 at 7:10 P.M. by President Stewart. President Stewart opened the meeting with a moment of reflection and followed by the Pledge of Allegiance led by Mr. Schneider.

## 5. REMARKS AND REPORTS OF CITY OFFICIALS:

## Council President Stewart: None

#### Mayor Whitfield:

Mayor Whitfield shared a photo of the parking area of Pioneer Plaza and explained that he wanted to clear up hearsay that the area was being transformed into a parking lot. Mayor Whitfield explained the vision is to maintain the space as a public park. Items from the area were removed due to construction, once construction is completed, reconsideration will be given regarding what type of items should be returned to the space. Some of the playground equipment had been used for urinals and the space being overcome with homeless population. President Stewart explained that the removal of the items without communication and a windfall of calls, just caught everyone off guard. In addition the removal of the 200th anniversary signs that were the efforts of many community groups and organizers. Mayor Whitfield responded that the signs have run their course and need to "add a new vibrant flavor to the city." He stated the

signage is pretty outdated. Mayor Whitfield invited the community out Saturday April 23, 2022 at 1:00PM to Oakwood that are interested in services for seniors and youth. President Stewart commented that he understood the discussion regarding Oakwood was scheduled for committee to further determine exactly what the plans were, then it was pulled from the committee agenda, now an open house is scheduled for the community. President Stewart explained he was not clear on the direction we were going with Oakwood. Mayor Whitfield responded that the administration has been very clear on the vision for Oakwood and would share with the public the same vision. Mayor Whitfield shared with President Stewart when details are ready to be shared, he will provide them. President Stewart raised concern about sustainability of Oakwood. It's one ting to make improvements to the building, it's another thing to sustain the building operations. Mayor Whitfield responded when the business model is prepared it will be shared, he further reminded everyone that Oakwood was not the idea or vision of the administration, council voted to acquire the building. Council member Mitchell thought a senior service center would be a great idea, the administration then considered how can the space be best utilized for potential income. Mr. Stewart explained that the purchase of Oakwood was in partnership with Elyria Schools and to avoid demolition of the building and continued partnership, no plans were solidified. The building could have been used for a senior center, cold storage, a portion of the building demoed, and other ideas. Mayor Whitfield responded in repetition that there were no plans, therefore, the administration believes the senior center was the best of those ideas. Mrs. Mitchell shared that she and Ms. Davis did push for West Park to be a senior center, she believes there is great value in the idea. Mrs. Mitchell also wanted to share the importance of letting the public know that she and Mrs. Davis would not be in attendance at the open house because they will be in attendance at a conference all day. Mr. Oswald inquired of Engineer McKillips how far from Broad street the parking lot will be. Mayor Whitfield shared that he could answer the question: "The parking lot starts where the grass is currently at the end of the building is when the parking lot starts, so it doesn't infringe on any green space." Mr. Oswald asked if a portion of that space is where the library parking is to be, as part of a deal with Elyria Public Library. Mayor Whitfield confirmed yes. Mrs. Simmons asked if the open house was safe for the community with the roof being in ill repair. Mayor Whitfield stated that multiple tours have been conducted, he reminded everyone, that just last year, kids were in the school, he says the roof is in bad shape, however he doesn't believe it will cave in on anyone. ASSD Williams, confirmed that the roof does not impose any structural danger. There are leaks that need to be addressed. Ms. Davis shared that she visited Oakwood school last week, and several windows on the south side of the building were broken out. Ms. Davis suggested that some way the windows be secured immediately. ASSD Williams, stated that in discussion with the Safety Service Director, a decision was made not to board all of the windows up at ths time, due to replacement of the windows. SSD Brubaker spoke to a new plastic material that is being considered over boarding the windows that will save the framework of the windows. Mrs. Mitchell inquired if Oakwood is on the City of Elyria insurance policy. ASSD Williams confirmed yes. Mayor Whitfield shared the importance of getting buildings activated, these things happen.

## Safety Service Director Brubaker:

SSD Brubaker shared that he placed at every member's sea as well as Law Director and Clerk of Council, high grass letter. The high grass season will begin May 1<sup>st</sup>. SSD Brubaker explained that the notifications for high grass will assist our newest council members with understanding the process. In addition, council members and residents can contact the building department or safety services department to file high grass complaints that exceed eight inches.

## Finance Director Pileski:

Finance Director Pileski shared that he wanted to provide a heads up regarding a new bill that has been introduced to the House of Representatives, HB 512. HB 512 will increase the pension costs for police and fire for all cities in Ohio. Currently, cities in Ohio pay 19.5 % of gross pay for police, 24% for fire. This bill would increase the police gross from 19.5% to 26% and fire gross from 24% to 26.5%. The bill indicates that it will be phased in over a five year period. Mr. Pileski expressed that if the rates were in place this year, it would cost the city an additional \$653,000.00 per year in pension costs.
