Mayor Whitfield:

Mayor Whitfield shared that he wanted to start a resident spotlight. The first resident spotlight featured, Aaron Battle, a fan of the Elyria High School Pioneer Marching Band. Mr. Battle was a member of a virtual band last summer, he completed a season with the Cincinnati Tradition Competitive Drum and Bugle Corps. Mr. Battle auditioned and was accepted into a matrix A drum corps group along with other high school peers and college students. The matrix performing arts is a non-profit performing arts education organization located in Akron, Ohio. April 21, 2022, The Matrix won first place in a competition and was awarded the winter guard international independent world series. Mr. Battle is an instructor at the Grafton Center of Musical Arts. He is proficient in all percussion instruments. He is a senior at Midview High School and will graduate in June. He is a member of the Midview Marching Blue Concert band and Jazz band. He will attend the conservatory at Baldwin Wallace University in the fall of 2022, majoring in music education and percussion performance.

The other item of "good news" shared, was the State of Ohio awarded two grants for Elyria projects. One of the grants totaled two hundred thousand dollars in support of the Elyria Police

Department to help with crime prevention. The other grant totaled six hundred thousand dollars to help towards the eSports arena initiative with downtown Elyria site clean-up. Upcoming plans for Pride and Service Day scheduled for Saturday May 21, 2022, as well as planning for the Memorial Day Parade. If interested in participating, call the Mayor's office and look for a link on the City of Elyria website for registration. Wednesday May 4, the City of Elyria will be hosting the president of Jobs Ohio.

Mr. Oswald inquired if there was an update to the Skill City initiative with Lorain County Community College. Mayor Whitfield responded that plans are to provide an update along with a renewal request for next year, to be referred at the next council meeting.

Safety Service Director Brubaker:

SSD Brubaker shared a couple of reminders to tenured council members as well as an update to new council members regarding departmental workflow processes within the City. If requests can be submitted through Safety Service it would be helpful for prioritizing them through the system. In the event that a request is submitted for the Street Department, but their que is full, the Water Distribution team can be sent to complete the task. Department heads are attempting to complete projects for both Safety Service and council members, one direct line of communication is being requested. However, if emails and phone calls are submitted, the expectation is to respond promptly. Issues with potholes falls into different category, and the request is to continue to contact the Street department directly, the Street department can dispatch workers immediately to the areas of concern. SSD Brubaker introduced Nick Katsaras of First Energy to provide program details for residents regarding electric bills in the event financial assistance is needed now that the moratorium has been lifted for shut-offs. Nick Katsaras, First Energy- 6326 Lake Ave., Elyria, OH 44035.

Mr. Katsaras reiterated the utility memorandum for shutoff ended April 15, 2022. Mr. Katsaras wanted to remind all council members to reach out to their constituents to provide them with information regarding payment assistance programs that are available to residents. Mr. Katsaras explained that First Energy understands the unforeseen circumstances of the ongoing coronavirus pandemic, they would like resident to call for assistance opposed to not paying their bill. Customers can apply for assistance through www.firstenergycorp.com/billassist and click "Search Assistance Programs" to see available programs based on income and household size. Or call Monday through Friday from 8:00 a.m. to 6:00 p.m. 1-800-633-4766. The most common program is PIPP, Percentage of Income Payment Plan. Residents pay a percentage of their income and not their actual balance through the PIPP program. Another program available is HEAP, Home Energy Assistance Program, summer heat program, and winter heat program. To apply for PIPP and HEAP call 1-800-282-0880 or visit www.energyhelp.ohio.gov 211 is an additional resource for assistance, for additional information dial 211, text your ZIP code to 898211 or visit the 211 website. Chief Pelko:

Chief Pelko reported that three new police officers were hired on April 25, 2022. Two of the three officers will go through the Police Academy. The other officer will begin employment right away through the FTO program. Chief Pelko provided an update regarding no left turn issue at Northwood School, some signs have been placed in the area by both the Engineering and Street Departments. Verbal warnings have been given to residents for over a week, however EPD will start issuing citations. Elyria Police Department was awarded one hundred ninety-three thousand dollars by Governor DeWine for an ARPA reduction in Violent Crime grant. The grant will provide additional patrols in the southwest and south central areas of the city, in particular Wilkes Villa, West Way Gardens and Midview Crossings. Cameras will be installed, additional technology, extra patrols, block watches and community engagement.

Mr. Oswald asked if there is any possibility that cameras for the downtown area can be funded from some of the awarded grant dollars. Chief Pelko stated there will be discussion with Mayor Whitfield to confirm how the monies can be distributed to include the downtown area. Mrs. Mitchell asked about additional enforcement for residents that run traffic lights and stop signs. Chief Pelko, explained the Police force is understaffed. He is doing his best. President Stewart congratulated Chief Pelko on the grant.

Ms. McKillips updated council on the Water main replacement project on 2nd St. and Cedar St. will begin as early as May 9, 2022. The roadway will be open to through traffic, however residents are being asked to pay attention to signage. The second project will be Oberlin-Elyria Road water line, more information will be provided regarding the schedule. Burns Rd. will not begin until Lorain County Community College is out of school for the semester. Concrete streets bids will open the week of May 9th. The citywide signalized traffic monitoring system for

intersections is implemented, the servers built, the software is installed, however the department is waiting on equipment delivery, which is seven to eight months delayed, due to supply chain issues. President Stewart inquired if designated intersections have been determined for the new traffic monitoring system. Ms. McKillips responded that all the intersections on State route 57, some intersections in the downtown area, and a significant number of intersections throughout the city. Mr. Cerra asked how will the residents on Wurst Ct. be informed of accessibility issues with the water main project. Ms. McKillips explained access will need to be provided to residents. The contractor will provide additional information. Mr. Cerra inquired if there was a known time-frame for the Cleveland St. water main project. Ms. Mckillips stated the bid will take place in the summer, however the project will take place sometime during the winter season. Mrs. Mitchell inquired about a time-frame for the phase one of the street resurfacing. No time frame has been determined yet. Mr. Oswald inquired on the project start for Broad St. Mayor Whitfield shared that Engineer McKillips compiles a project summary list that can be distributed to everyone opposed to her reviewing every project. Mr. Tollett stated that he received a project summary six months ago that was very helpful and the summary provides the stage of every project that engineering has in progress.






