Finance Director Pileski explained that the Cities Tax Year 2023 Annual Budget of Estimated Revenues and Expenditures document is the beginning of the City of Elyria certificate of Estimated Resources with the Lorain County Budget Commission. The beginning cash balance will be replaced at the beginning of next year with the actual cash balances. Estimated revenues will be amended as revenues are received in 2023. Estimated expenditures in the document will be replaced by the permanent appropriation that council will pass by the end of March 2023. Upon the approval of the Elyria City Council, the document will be filed with the budget commission.


