# 5. REMARKS AND REPORTS OF CITY OFFICIALS:

### Mayor Whitfield:

Mayor Whitfield said he had some updates. They are seeing increased levels of Covid-19 cases here in Lorain County and he wants to encourage everyone to get their vaccinations and continue the good habits. Also, he wants to encourage everyone to get out and vote tomorrow, so their voices are heard.

This coming Wednesday, the City is partnering with our local Veteran's Organizations to host a Veteran's Night to honor them with a night out and sharing information about resources available to them. It will take place Wednesday at 5:30 at The American Legion Hall. City Hall will be closed Friday, November 11<sup>th</sup> in observance of Veteran's Day. The Elyria Council of Veteran's will be hosting is annual Veteran's Day Program on Friday at 11:00A.M. at The American Legion.

Last year at this time he addressed Council with a mini State of the City Address which provided updates on City affairs and challenges. He plans to do that again this year. Mayor Whitfield asked if anyone has ideas for that address to please share those with him and they will be presented as a preview to the 2023 budget and he'll be seeking Council's approval.

Lastly, he gave a shout out to the City's Street Department, they've done an amazing job collecting leaves around the City and the residents appreciate how quickly the leaves get collected. And he hopes everyone can get out and enjoy this beautiful weather.

President Stewart asked how much longer the City will be collecting leaves?

### Safety Service Director Brubaker:

Dir Brubaker said they collect thru the first full week of December and at that time folks are encouraged to bag that at that time. But as long as the weather holds out they will continue. He reminded everyone that the same trucks that pull the trailers for leaf pick-up are the same trucks that plow the snow.

Sanitation will not be delayed this week.

In regards to the Shane Furniture Building, there were issues last week and kudos to our Engineering Team for being on top of that. Part of the building collapsed onto the adjoining building and caused damage to the roof and third floor of that building. A contractor and a structural Engineers was planning out how to shore up the building that was damaged, which was 333 Broad Street and they will work on building a temporary roof and fixing that beginning as soon as tomorrow. Four engineers from two different companies have suggested that that building is salvageable. They were looking at it and he anticipates that building we be saved. The contractor is only allowed to remove by parts of the building by hand. They had been using jack hammers. Once the building is shored up and secured they will be allowed to resume using the equipment. Unfortunately it will be another couple of weeks before the building can be safely brought down. The front of the building is a huge concern, that's why Broad Street is still closed. The Engineering Dept; Mr. Gallagher, Mr. Forthofer, Mr. Schneider and Ms. McKillips are all on top of that.

Mr. Callahan asked, with the part of the building collapsing onto the business next door, will the contractor's insurance be responsible for that?

Mr. Brubaker said that everything is on the table, they do have insurance and a bond. Mrs. Mitchell said she was there when all of this happened and the compassion that was shown to the business owners was professional and she wanted to thank everyone.

# Finance Director Pileski: No report

Director Deery said, this situation of the Shane Building is not a situation that we what to put our business owners in. This contractor is bonded and they cover insurance which was verified and that's why we require the contractors to indemnify the City. We're grateful no one was hurt and we're fortunate to have police, fire and engineers to be there to assist.

# **Police Chief Pelko:**

Chief Pelko said he wants to give an update on the body cameras.

They're rolling out the training for their body cameras and he still anticipates they will be out on the officers and in the streets by the end of the month. Sergeants that are out on the road will have them on their person as well. It's 'No-Shave' November and they donate to St. Jude's Charity and if anyone is interested and want to kick in to let him know.

# City Engineer McKillips: No Report

Mr. Oswald asked for an update on Broad Street. He wants everyone to understand that it's going to be a long project which will take awhile. But if they remember how long it took to complete East River Street and how nice it is now.

Engineer McKillips said\_right now, our utility companies infra source working for Columbia Gas will have Thompson Electric working for Ohio Edison and Windstream will be relocating utilities in preparation for the project. They're expecting Federal authorization by mid-January so they can go out for bid. The time line for the utility relocation is aiming for the end of this year for Columbia Gas and Ohio Edison, weather permitting and a lot of Windstream facilities end up on a lot of Ohio Edison poles, they'll follow up with Ohio Edison and complete their work by the end of February.

For the current condition, which isn't good and will get even worse with the moving of the utilities. During the winter they will have contractors that working for the utility companies and they'll be responsible for their trenches and trenches that are leftover from the lead line water services or other projects that have been in the works and performed until they actually start ripping up the road and end up with a beautiful roadway heading into downtown.

Mr. Lipian asked if there's been any progress on the shared-use path on East Broad which many 1<sup>st</sup> Ward residents have asked about.

Engineer McKillips said that is coming along and the bidding of that project should take place in January-February. When they're ready to bid out, there will be language in the document that will indicate an alternate.

President Stewart said Engineer McKillips handed out a paper on November 1<sup>st</sup> for Council members to sign up for the ride-a-long for the streets.

Engineer McKillips said she has received requests from several council members who will request those ride-a-longs and they will be scheduled in next few weeks.

Mr. Lipian had an additional question, it was about Sugar Lane which has a lot of bumps and grates on that road and business owners have complained that it's difficult for their trucks to drive on that road. Knowing that Issue 6 funds don't pave with concrete. He asked Engineer McKillips if she recommends Sugar Lane with concrete or can it be a potential Issue 6 project?

Engineer McKillips said they can look into using Issue 6 funds for concrete repair. They've used full depth concrete replacement, which isn't the entire road, but just the areas that are bad, which would be cut out and replaced with full depth concrete. Depending on the condition of the old existing concrete, it may or may not be a candidate for asphalt resurfacing on top of it.

She said that they actually have Sugar Lane on the list to review.

Residents of the first ward are concerned about Safety. There have been many accidents due to speeding and disobeying Stop Signs. They value their parks and recreational enclave in Eastern Heights.

Communication is also important, as many programs exist, but so many don't know they exist. Deterring crime and bolstering business also matters. They prize transparency and the desire for the first ward is for public comments during open meetings to be on mic and on the record. This will help build confidence in our municipal government from those who were elected to represent. Therefore for the remainder of the ARPA dollars through the end of the year or perhaps through other means, Ward one residents will have Mr. Lipian request the following:

- 1.) 20 LED Stop Signs (solar powered),
- 2.) 3 Speed radar digital signs assigned only to the 1st ward
- 3.) 2 Temporary speed bumps so they can test their effectiveness
- 4.) 4 3-D painted speed bumps

- 5.) Bike pumping station in East Park
- 6.) Bleachers for outdoor basketball court and painted soccer lines on the field

- 8.) Residential lights on S. Logan Street to help deter crime
- 9.) Informational flyer to send out to Ward 1 Businesses informing them of business resources available to them

Whether all or some of this can be paid for with ARPA, they appreciate the Mayor considering these requests.

The residents also asked Mr. Lipian to make a note on decorum in our government; with wars abroad and violence on our streets, many people in our City have experienced a loss of faith in humanity and this is understandable, however, as leaders in our City, we are it. Elyrians are depending on us to work together as a team and lift them out from their travails or at least make life a little less troublesome. With our national political climate so toxic, we do not have to fall under that sway. Let us build together durable relationships, let us align under one banner and let us soften hardened hearts. Having a grand debate, not petty quarrels and shouldering our burdens with skepticism, but not mutual- suspicion. Then, and only then, can we restore their faith in Humanity. The 1<sup>st</sup> Ward is ready to take up this responsibility, they hope they are not alone. Thank you.

President Stewart thanked The Mayor and said he agrees that we're trying to move this City forward. We know this is an unprecedented windfall of money and we call that over and through and to try to advance the City. Obviously we're trying to be cognizant of spending those dollars and the best use of those dollars. We look forward to working with the Mayor and moving the City forward.

Mrs. Mitchell asked the Mayor if we can use some of the ARPA money to spend on streets?

Mayor Whitfield said that will be a part of their presentation. He appreciates one of the things that was done last year. Through Council's recommendation, the residents didn't get a chance to enjoy the roads, because by the time they were done, we were getting ready for snow. So, since it was recommended to choose them early and they got done early and the residents got a chance to enjoy the roads. Again, we're getting things, but want to get more done.

Mr. Oswald said he's a positive person and he sees a lot of things that are happening in the City that residents tend to forget. Look at all the growth on the South Side of town, the two developments, the Sheetz and Aldi that will be built. He said there is a development at Bender and Sugar Ridge, and that will feed on needing some retail to possibly be built on the Connector Road and the area where Sheetz and Aldi will be built.

Dear City Leadership,

I am unable to attend this important meeting to discuss the use of ARPA funds for Elyria due to a work conflict.

I want to take this opportunity to have my comments read into the record and offer suggestions to tonight's discussions relative to the use of these dollars.

This windfall of cash is a tremendous shot in the arm for our community and, as such, you must be thoughtful and unselfish stewards of these dollars. These monies must be used for things that support and enhance the community in meaningful ways.

One of the key factors in a growing community is education – the Elyria City Schools have taken that challenge and built all new schools – check that off the list!

The next <u>most</u> critical issue for hundreds of families here now and in the future, is safety. We are a critical juncture for the expansion of the services that Elyria Police and Fire deliver. The hundreds of houses that are being built at the fringe of our community's boundaries cannot be served in a timely manner without revamped stations. Much of the new construction lies in areas that are both inside of and outside of Elyria's boundaries. As this continues our safety forces transgress township and other unincorporated areas to deliver services — with areas getting further and further from centralized Elyria.

The next priority is to improve the horrible central garage. No one in this community would buy a brand-new truck or car and leave it out to the elements. This facility is over 50 years old and is not adequate to maintain the millions of dollars of rolling stock we have. A comprehensive plan has been discussed and developed and it is time to get that process started. This investment will protect equipment and sustain it for much longer - using those Issue 6 dollars wisely.

Thirdly — I implore you to look at the conditions of the railroad underpasses. Use some small portion of these dollars to improve at one or two - perhaps the most seen ones — East Bridge Street and Washington Avenue. No investment to the downtown is going to happen without some refreshed esthetics. The railroads are not going to beautify these structures — it is up to us.

Leaders – resist the leanings of fancy swimming pools and such...these items, including a senior center are admirable. They will always be in the "nice to have" category and cannot measure up against safety services or maintaining expensive equipment.
