Chief Pelko said it's some larger items that they can't store at the Police Dept. The Department has been renting a place for this storage for about 20 years.

The Chief said he is currently in the process of speaking with an architect to get some plans developed to construct a building on the Police Dept. property so they won't have to rent space from a private business.

Law Dir Deery said the previous ordinance characterized the storage as police evidence.
