#### Safety Service Director Brubaker:

Safety Service Director Brubaker stated this would be the last city council he would be in attendance. He expressed what an honor an privilege it had been to serve the residents of Elyria for so many years. Mr. Brubaker shared that he was humbled to have worked under three administrations: Mayors, Grace, Brinda, Whitfield. He thanked all administrations and their staff, as well as his two assistant directors Mr. Williams and Ms. Calvert. Mr. Brubaker shared that his experiences under all three administrations although vastly different, were similar, he appreciated the confidence bestowed on him. He thanked city council members, Law Dir. Deery, Asst. Law Dir. Breunig, Fin. Dir. Pileski and Asst. Fin. Dir. Farrell, Clerk of Council Bullocks, Clerk of Council Lotko, Colleen and Regan, Nell and Carol, Judge Bennett and staff, Judge White and staff, Clerk of Court Rothgery. Mr. Brubaker went on to thank department heads and chapter 165 employees and supervisors that are the people who really do the work that was normally requested of him. Mr. Brubaker stated he was fortunate even to hire both a new Police and Fire Chief, leading their departments was an honor. He thanked all three unions and their Presidents, as well as captain Hammonds, Sergeant Ligas and Lieutenant Cunningham, Mr. Brubaker closed with relationships built his success over the years.

President Stewart thanked Mr. Brubaker and stated that he has done an incredible job over the years. He wished him the best in his future endeavors.

Mrs. Mitchell shared expressed that she was certainly one to call at al times of the day or night. she expressed her appreciation for Mr. Brubaker and his time always making her look good. Mrs.

Police Chief Pelko: No report

Extended a thank you for years of service, referenced Mr. Brubaker as "Mr. Elyria." Mr. Lipian inquired about no shave November. Chief Pelko shared, the goal was reached. The campaign will extend out to February 1, 2023 for officers. The campaign has been enjoyable and motivating. He thanked everyone who donated to the campaign.

Fire Chief Pronesti:

Chief Pronesti shared that the weekend resulted in multiple fatalities. He has shared before the importance of checking smoke detectors, and reminded everyone once again how vitally important it is. There were no working smoke detectors inside the apartments. Chief Pronesti encouraged everyone to work together to eliminate fatal fires in multi-family dwellings. He shared in his tenure as chief, there have been three fatal fires in multi-family dwellings. He explained that challenges exist, he will be dilligent and creative working with other departments to come up with solutions for install of smoke detectors and sprinklers. Chief Pronesti asked that we keep the fire department in our thoughts as over the weekend, some of the workers experiences three fatalities in less than seventy -two hours, in addition to the loss of a fellow Cleveland firefighter. Mrs. Mitchell commended the Chief on a job well done and inquired about a program to distribute smoke detectors to residents. Chief Pronesti responded a program does exist, it may not e advertised well. The union purchases the smoke detectors and distribution is by request. Mr. Oswald commented that as a landlord educational programming would be beneficial as well, as he has experienced tenants that have detectors and not aware of battery replacement. Chief Pronesti read a quote, "Leadership is the capacity and will to rally men and women to a common purpose and the character which inspires confidence." Field Marshal Bernard Law Montgomery. He shared the quote is descriptive of Mr. Brubaker and that the tings that he taught him makes him a better boss.

Asst. Dir. Calvert: No report

ASSD Calvert shared that it has been a pleasure to learn from Mr. Brubaker over the last three years that sometimes felt like ten years.

Asst. Dir Williams: No report

Mr. Williams shared that he admires Mr. Brubaker and views him as the master of relationships and the amazement that he genuinely knew something of every employee.

<u>City Engineer McKillips:</u> No report Ms. McKillips thanked Mr. Brubaker for his leadership, mentorship and morning conversations, that provided growth for the engineering department.

Mrs. Mitchell expressed her appreciation to Ms. McKillips for organizing a ride along between council and engineering for street inspection. She said that her ride along with Mr. Forthofer, was informative, and helpful and provided he the opportunity to complete her street list.

# Elyria says goodbye to Kevin Brubaker

ELYRIA - Elyria Safety Service Director Kevin Brubaker said his goodbyes Monday in his final Elyria City Council meeting before his departure at the end of the month.

Brubaker, thanked Elyrians and the city, saying he was both honored and humbled to have had the opportunity to serve under three mayors over more than a decade. He said he was most of the relationships he has built that have enabled his success and the success of Elyria in getting things done.

"Because without those relationships, you can't collaborate, you can't do anything. And if you're not gonna have those relationships built into what you're trying to do ... relationships isn't always about who's right or who's wrong, It's about accomplishing things and seeing the city forward," Brubaker said. "And that's probably what I would take away from my years in this role, the many roles that I had in the city, my role on city council is the relationships, and I will miss those deeply."

Brubaker will become the new public works director for the city of Avon Lake beginning Dec. 1 and he said he hopes to take much of his experiences in making an impact in his new role.

One by one department heads and members of Council reflected on Brubaker's impact in making Elyria a better place to live and imparting his wisdom on those around him.

Elyria Police Chief William Pelko called Brubaker the most dedicated professional he had ever worked with.

"You are a mover and a shaker for the city as well as a doer. We can count on you to get things done. You always have what is best for the city as your top priority. You are Mr. Elyria You will be truly missed. We all wish you the best of luck with your new endeavor. Elyria's loss is Avon Lake's gain," Pelko said.

Elyria Fire Chief Joe Pronesti compared Brubaker's leadership to that of a great general, leading with character and inspiring others to rally to their cause.

"I've been around a few safety directors and the things that you taught me are just something that really made me a better boss. And that has something to say about your leadership," Pronesti said.

Mayor Frank Whitfield was not in attendance Monday, but he addressed Brubaker's departure in a post to his official Facebook page recognizing him for his commitment to Elyrians.

"First off, let me thank you for your years of service to the city of Elyria. Over the past three years, we have worked closely together and faced many challenges that only a few would understand. We got the calls in the middle of the night when tragedy struck and we dealt with the storms before our residents could feel



them," the mayor wrote. "We rarely disagreed, never argued, and when we disagreed we found a way to move forward without losing respect for one another. That's why it's sad to see you go, but I totally understand and I wish you well in your new job."

Avon Lake City Council formally approved Brubaker's hiring last week at an annual salary of \$110,000.
