January 17, 2023 Regular Council Meeting Elyria City Council

1. CALL TO ORDER:

The regular meeting of Elyria City Council was called to order on January 17, 2023 at 7:00 p.m. by President Stewart. President Stewart opened the meeting with a moment of reflection, followed by the Pledge of Allegiance led by Mr. Corbin.

4. APPROVAL OF MINUTES:

Mr. Cerra moved, Mr. Schneider seconded to approve the Regular Meeting Minutes of the January 3, 2023 council meeting as circulated.

5. REMARKS AND REPORTS OF CITY OFFICIALS:

Mayor Whitfield:

Mayor Whitfield thanked the community for showing up for the Martin Luther King celebration that was held on Monday January 16, 2023 at Elyria High School, and for participation in the break out sessions. Mayor Whitfield shared the kick-off of the comprehensive land use planning effort was held. All residents are encouraged to complete a survey at ourelyria.com. He shared the next public meeting would be held February 6, 2026 at 6:00pm, where information would be shared regarding what a comprehensive land use plan is.

Safety Service Director Lundy:

SSD Lundy provided an update of preparation for the predicted snow storm. Crews were more than prepared, however the anticipated accumulation did not happen. SSD Lundy provided an update on the status of salt: 9000 tons of salt was purchased through the ODOT purchasing program, the city started the season with 4000 tons of salt. In December 800 tons was purchased and the beginning of January another 1100 tons. A minimum purchase of 8000 tons is required through the program.

5. REMARKS AND REPORTS OF CITY OFFICIALS: CONTINUED

Finance Director Pileski:

Finance Director Pileski requested a referral from the floor: The matter of paying an unencumbered bill from 2022.

Law Director Deery:

Law Director Deery requested that a matter be addressed under miscellaneous and unfinished business based on the actions of the Rules Committee that held a scheduled meeting February 6th at 6:00 p.m. that pertains to a charter Amendment. Article 3, Section 3.12.

Mr. Lipian inquired about the recent bill for expunging marijuana records that was signed by the Ohio Governor, are there plans for the city of Elyria Law Director to look into expunging records? Law Director Deery responded, traditionally expungement requests are initiated by defendants, so at this time employees, colleagues or prosecutors would not be initiating expungements, however that does not mean they wold not review items received through the Elyria Municipal Court.

Police Chief Pelko: No report

Fire Chief Pronesti: No report

Mr. Lipian asked if the Fire Chief Pronesti would like to speak about a safety and communication incident? Chief Pronesti explained the event was the Lorain County Commissioner's meeting. He thanked Mayor Whitfield for attending the meeting and expressed his appreciation to the Mayor for taking a stand alongside the fire staff regarding the safety issue. Chief Pronesti explained the issue concerned the Commissioners vote to rescind the contract for radios. He explained the Elyria Fire has no communication with the cities of North Ridgeville or Sheffield Village. Mr. Lipian questioned the idea of the city of Elyria looking into ARPA funding to purchase radios outside of the coordinated efforts. Chief Pronesti responded that it would be very expensive and the radios would allow for communications with all surrounding cities. He explained the request has been a group effort with all fire chiefs, however for the safety of Elyria fire, he would entertain a discussion. SSD Lundy stated that in his opinion the county should honor their commitment as this is an important safety issue for the county. He explained the city of Elyria agreed to the subscription end of the agreement, and anything beyond that is not fair or reasonable. Chief Pronesti expressed his appreciation for Mr. Lundy's statement, and explained further, that if the city of Elyria obtained it's own funding, the other cities without mutual aid not on the system, would not have the ability to communicate. The same problem would exist. Mr. Tollett posed a question to Mr. Lundy, Law Director Deery and Chief Pronesti, "did the comissioners go against their legal counsel by voiding the agreement that was previously passed." Law Director Deery repsonded that she can not speculate on the legalities of the commissioners' recision. Chief Pronesti shared nothing has united fire safety forces like this issue with the radios. He thanked everyone for their support.

5. REMARKS AND REPORTS OF CITY OFFICIALS: CONTINUED

ASSD Williams:

ASSD Williams shared that he had the pleasure of participating in a parks and recreation board meeting on January 12th. He explained that robust discussion was had centered around the 2022 Parks and Recreation Master Plan update. The discussion was led by Pat Hoagland of Brandstetter Carroll Inc. Mr. Williams shared that Director Reardon would provide updates from the master plan and share information on ways that council members can participate. Mr. Williams recognized and commended Director Reardon and her staff on their presentation of the master plan during a break out session at the Martin Luther King Jr. Celebration. They did an excellent job.

Assistant Service Director Calvert:

ASSD Calvert provided an update on the Shane building demolition due to inquiries received. Ms. Calvert, explained the demolition is not technically completed, debris is still being cleaned up. The next steps will be waterproofing the exterior portion of the building and backfilling with clean filter. The next phase will be to weatherize and provide safety precautions to the adjoining buildings. President Stewart inquired about discussion of the events of the demolition. Law Director Deery advised that no discussion should be held in an open forum regarding the demolition. Mrs. Mitchell stated that she believes all can agree that the Shane demolition was a complete disaster, she hopes the businesses will be made whole because they suffered in the process of the demolition and with the hiring of a professional company, the incidents never should have happened. Mayor Whitfield suggested that he would like to schedule an economic development committee meeting to discuss businesses that have been impacted, as well as policies and procedures for the lowest bid, as the lowest bid may not be the best bid.

Engineer McKillips:

Engineer McKillips provided an update on the Eastside sewer relief project on Poplar Street. Two sections of pipe stretching twenty feet long was installed. Crews are excavating with care due to utilities. The week of January 23rd, Underground Utilities will begin the water main replacement project on Cleveland Street. Utility companies are continuing to relocate their facilities along East Broad Street. Ms. McKillips shared that the engineering department is awaiting approval from ODOT (Ohio Department of Transportation) District three for central office review as well as Federal Highway review of the multi purpose path for concrete or asphalt. The engineering office is working on a map that will depict road closures and detours that will be accessible on the city website. Mrs. Mitchell provided a reminder to council members to schedule a ride along and provide Ms. McKillips with 2023 ward street lists. Mr. Cerra, explained that two big projects at the same time in the St. Jude area provides for a challenge for residents to travel. He inquired about project coordination. Ms. McKillips responded that inspectors will be assigned on both projects that will communicate back and forth, along with traffic techs in the office to avoid a street that is blocked at both ends. Ms. Davis thanked Engineer McKillips for updates that are received from her, she explained how helpful the correspondences are in their ability to respond to residents. Mr. Lipian expressed that members of the first ward would prefer concrete paths opposed to asphalt and would like to be included in

collaboration regarding the multi use paths. Mr. Tollett thanked Engineer McKillips for her coordination of the five hundred families in the St. Jude during the Christmas break in communicating traffic pattern updates. President Stewart inquired about what the reasoning is for reflector paddles along the railroad tracks, north and south of Abbe Road. Ms. McKillips explained the delineators are also on Olive and Murray Ridge Rd. and West Ridge. It is part of a project for a quiet zone for the railroad tracks.

WWPC Superintendent Korzan: No Report

P& R Director Reardon:

Director Reardon explained that ASSD Williams was distributing to each council member a draft copy of the 2016 parks and recreation master plan updated for 2023. The process was not to start over completely because the 2016 plan is fairly new and due to issue six funding, the department had been able to accomplish many of the projects listed from the 2016 master plan. The goal is over the next six to ten yeas that the master plan will serve as a road map for the department projects. Ms. Reardon explained, in 2020 the department started to engage te community by requesting feedback through community engagement surveys. Ms. Reardon explained that additional survey requests were submitted at the MLK Jr. Event during the break out session with a due date of February 15, 2023. The results will be submitted to the parks board. The parks board has also provided their feedback via the survey. The goal is that the parks board will adopt the feedback March of 2023, then present the information to council for adoption as well. Some projects yet to be completed from the 2016 master plan, include the family aquatic center, a splash pad at North recreation center, expansion of South park recreation center, additional basketball courts at East recreation center, Academy court, West recreation center and Hilltop Park, an amphitheater, an upgraded playground at West recreation center, walking trails and updates at Finwood.

New recommendations include, update ball diamond at North recreation center, changing Academy Court from football to soccer, and adding the pocket park. Ms. Davis suggested that Bell Ave. Tot lot name change be considered. Ms. Davis also asked if signs would be replaced that provided and age limit to the play area. Mrs. Mitchell asked when is the anticipated time frame of the walking trail at West Park. Ms. Reardon stated she was hopeful that a preconstruction meeting could be scheduled over the next three weeks. Mrs. Mitchell inquired about the pickleball court at West park as well. Ms. Reardon explained that is on the same contract as the walking trail. President Stewart asked for an update on programming. Ms. Rreardon shared, programing was apart of the feedback received during the breakout session. Popular program will continue, and yoga will be added, along with adult basketball leagues. The are only working on the idea of a mobile recreation program, additional movies in the park. March 1st the spring and summer brochure will be published with all program listings.






Condition of Parks




Upgrades to Existing Parks - Top Responses

Stakeholder Meetings

A series of Stakeholder meetings were held in September of 2021 which included representatives of the city Administration, Parks and Recreation Department, Parks and Recreation Board, Council Members, CDBG Office, and others. The results of these meetings is included in in Appendix C. These meetings provided background and recommendations which are represented in the recommendations of this Master Plan Update.

South Elyria Pocket Park Engagement

The city, Leaders of Today, Lorain County Public Health hosted an event on August 27, 2022 at the proposed pocket park location at 15th Street and West Avenue to engage the community on desired improvements for this new park. Approximately 175 people participated in the engagement. The results can be found in Appendix D.



A new survey was prepared to provide input from residents as a follow-up to the one that was included in the 2016 Master Plan. Several of the questions were very similar so that the results can be compared. A web-based and handout survey was prepared, distributed, and completed in the fall of 2020 and spring of 2021. A total of 853 responses were provided. This section of text provides a summary of the results of that survey.

3.1 PARTICIPANT LOCATION

Of the surveys, 81% of the respondents lived in the City of Elyria with approximately 33% living closest to East Park, 32% closest to North Park, 23% closest to West Park, and 12% closest to South Park.

Figure 3.1: Closest Park to Respondents





Figure 3.2: Elyria Parks Visitation




3.2 PARK VISITATION

3.3 PARKS AND FACILITIES VISITED


Figure 3.3 summarizes the results of the question asking which park people visited the most. Not surprisingly, the parks with more facilities were visited by most people with Cascade Park and Elywoods the highest at 74%, followed by the Finwood Estate and Finwood Forest at 56%, East Park Pool and Recreation Center at 53%, West Park and West Recreation Center at 53%, and North Park Pool and Ice Rink at 53%.

3.4 FREQUENCY OF PARK VISITATION

When asked how often they visited the parks in Elyria, it was Figure 3.4: Frequency of Visitation to Parks noted that almost 58% visited parks 20 or more visits in the last year which states that people have been visiting parks at a high degree. This is shown on Figure 3.4.



3.5 PARK CONDITION

Residents were asked to rate the condition of the existing parks. They rated as follows: 20% rated they were in Excellent Condition, 60% in Good Condition, 18% in Fair Condition, and 1% in Poor Condition. This is shown on Figure 3.5.

3.6 PROGRAM PARTICIPATION




Figure 3.6: Participation in Programs




Figure 3.7: Programs Used

Figure 3.6 identifies that 66.5% of the respondents stated that they have participated in programs offered by the City of Elyria in the last two years. Figure 3.7 identifies those programs which people stated they used the most with the highest ones including Swim Lessons at 31%, Youth Soccer at 24%, Youth Basketball at 21%, Safety Town at 16%, Ice Skating Lessons at 15%, Youth Volleyball at 20%.

Figure 3.5: Condition of Parks






Figure 3.8 identifies the respondents rating of the quality of those programs offered with 45.7% indicating they are Excellent, 44.7% indicating Good, generally indicating satisfaction with the current level of programming.

3.7 FACILITY NEEDS

Figure 3.9 summarizes the results of a question which asked respondents to identify those facilities needing upgrades at existing parks with the highest being: Drinking Fountains with Bottle Fillers at 50%, Improve and Add Restrooms at 49.8%, Security Cameras and Lighting at 49%, Bike Trails at 45%, Dog Parks at 39%, Expand Trails at 35%, and others as indicated in the table.





3.8 UNMET FACILITY NEEDS

Respondents were asked to identify those facilities which are not currently meeting their needs and were allowed to select up to four. Indoor Swimming Pool was indicated by 37% of the respondents, Dog Parks at 29%, Outdoor Swimming Pools and Aquatic Centers at 22%, Trails for Walking at 16%, Stage or Amphitheater at 15%, Paved Bike Trails at 15%, Senior Center at 14%, and other items as shown on Figure 3.10.

Figure 3.11: Unmet Program Needs





Figure 3.12: Reasons for Not Using Parks, Facilities, and Programs

3.12 SURVEY DEMOGRAPHICS

Figure 3.14 illustrates a comparison of the age of the household members of those responding households as compared to the actual census data for the City of Elyria. Figure 3.14 illustrates the City of Elyria census information in gray and the web survey respondents in blue. This table generally shows an over-representation for families with children and 35 to 44 year-olds and under-representation for the 25 to 34 year-olds, and those 45 and older.

3.13 RACE AND ETHNICITY

Figure 3.15 illustrates the race and ethnicity for the respondents to the survey as compared to the US Census information for the City of Elyria which is indicated in gray. This shows a slight over-representation by the white population and a small under-representation of the black and African-American, Hispanic or Latino, or multiracial, and multi-ethnic populations.



3.14 MIND MIXER ONLINE ENGAGEMENT

The Consultants also had an Online Engagement Platform which was hosted through Mind Mixer. This received 1,156 page views and had 60 participants overall.



4.1 PARKS PLAN FOR EQUITY

This Chapter of the Master Plan Update identifies those recommended projects that will continue toward accomplishing the Vision, Mission, Goals, and Objectives of the 2016 Master Plan. It is enlightened by those changes which have occurred since the completion of the 2016 Master Plan and changes in priorities resulting from changes in Administration, Elected Officials, and staffing, as well as economic conditions.

The goal of the recommendations in this Master Plan Update is to move towards equity among the various quadrants of the City of Elyria. It is not intended that the facilities and programs offered be the same in each quadrant of the community, but there should be a variety of facilities and opportunities in each area with several unique or larger facilities. These would then be supplemented by the neighborhood parks and other parks throughout the community to provide close to home opportunities for residents.

The recommendations to accomplish the equitable distribution of facilities throughout the city include the following major components at each of the Community Parks.

- 1. East Park
 - Recreation Center
 - Modern Outdoor Family Aquatic Center
 - Large Playground, Walking Trails
- 2. North Park
 - Ice Rink
 - New Splash Pad
 - Baseball/Softball Fields
 - Playground
- 3. West Park
 - Recreation Center
 - Splashpad
 - Perimeter Walking Trails
 - Pickleball Courts

RECOMMENDED IMPROVEMENTS 19

- Adult Softball Fields
- Soccer Complex
- Skate Park
- Large All-Access Playground
- Oakwood Community Center to provide a wide variety of recreational, social, and cultural activities

4. South Park

- The largest of the Recreation Centers
- Splashpad
- Walking Trails
- Picnic Areas
- Tennis Courts
- Large Multi-Purpose Fields
- Baseball Fields

These major facilities, in conjunction with those offered at Cascade Park and Elywood Forest and those at Hilltop Park, provide an equitable distribution of facilities and access to unique facilities throughout the City of Elyria.

4.2 INDIVIDUAL PARK RECOMMENDATIONS

4.2.1 East Park (Figure 4.2)

The main new attraction to be included at East Park would be a modern Outdoor Family Aquatic Center with features as identified in Figure 4.1.

The potential features are shown on Figure 4.1 and illustrated are large slides, climbing walls, water play features, along with zero depth access and other amenities. The reasoning behind the selection of East Park for the implementation of the Family Aquatic Center are the following:

- It has the largest population within a 10 minute walk or 5 minute drive of all of the regional parks.
- When all four pools were in operation, it had the largest attendance by far.
- South and West Parks have new splashpads and there is little room to expand the North Park Pool to
 provide the needed features to attract the type of attendance this could attract.
- The budget and operations cost of operating the four pools originally, and down to two pools in recent years, is not sustainable. The goal for a long period of time has been to have one large Family Aquatic Center that would appeal to all residents of the City. This will be more sustainable and manageable for the City to operate and with the right design and operations, could recuperate its operating costs. Figures 4.2 and 4.3 provide alternative locations for the development of this Family Aquatic Center. One location would be where the pool is currently located and would have the parking lot expanded on the north side of the Recreation Center to accommodate this facility. The other option is to place the Aquatic Center on the south side of the Recreation Center, which would require additional parking and also relocation of the basketball courts to the location of the current pool. There is more room for the development of the Aquatic Center on the south side of the Recreation Center than on the north side. Either of these concepts will work and and Consultants recommend keeping the aquatic facility to the north side of the recreation center to take advantage of the existing utility access. Other proposed features include four pickleball courts and a second basketball court.

4.2.2 North Park (Figure 4.4)

Renovations have recently taken place at the North Park Ice Rink. Other factors to be considered for North Park is that the playground is currently in the process of being replaced and upgraded. There is very little room to expand the existing pool, and Little League North has consolidated with the other Little Leagues

and the fields are not used as much as they once were. Therefore, the recommendation is to continue the upgrading of the playgrounds and the ice rink, and develop a new baseball themed splash pad.

4.2.3 South Park (Figure 4-5)

South Park currently has the largest Recreation Center with two gym floors in the city, as well as a relatively new splashpad, and new walking trails that were completed in 2021. In addition, the tennis courts have been renovated. The recommendations for this park are to add an additional ball field near the current field with a paved parking lot and picnic shelter in this area to expand the picnicking opportunities. Another recommendation is to develop the large open field in the southeast corner of the park and where youth football previously took place and use this area for the development of two high quality multi-purpose athletic fields. Ideally, if funding is available, these would be artificial turf fields which would provide a unique facility for this area of the community.

4.2.4 West Park (Figure 4-6)

West Park is currently the major hub for adult softball and has the C.R. Hoagland Recreation Center within the site. The current Land and Water Conservation Fund Grant will allow for the development of a perimeter walking trail, four pickleball courts, and a new restroom building. The park also has a recently completed splashpad and picnic shelter adjacent to the skate park. The City's recent acquisition of the Oakwood School allows tremendous opportunity to convert this facility to a true Community Center which offers social, cultural, educational, and senior programs, and dedicated space rather than shared space in the gymnasiums as this is where the current programs are located. This is a tremendous opportunity for the city and for the west side of the community.

Other recommendations for this park include the development of an all-access large playground to serve the western portion of the community and the addition of a second basketball court.

4.2.5 Other Park Improvements

The proposed improvements for the neighborhood parks, mini-parks, and special use parks are listed in Table 4.1. The majority of the improvements have been brought forward from the 2016 Master Plan and the costs updated.

One new potential park is located at the corner of West Avenue and 15th Street and adjacent to the Elyria Public Library South Branch. The total site is 0.16 acres. This location could serve as a small neighborhood gathering place with a small playground, picnic shelter, and plaza space. The space could also support programs offered at the adjacent library.

On Saturday, August 27th, Leaders of Today, Lorain County Public Health, and City of Elyria hosted the South Elyria Pocket Park Community Kick-off at 1504 West Avenue, Elyria, Ohio. The event served as a temporary demonstration to engage residents on the needs and desired park improvements shown by the initial survey. The event totaled approximately 175 people and additional data was collected during the event and via door-to-door to gain insight on desired permanent park improvements. The results of this engagement can be found in Appendix D.

This Estimate excludes escalation. Current market conditions make it extremely difficult to forecast into the future. The last twelve months saw a rapid increase in construction pricing. Going forward, we believe those increases will be hard to maintain and eventually pricing will increase at a more historic rate. Unfortunately, we don't know when that will occur. To further complicate issues, there are material shortages. Obtaining all of these materials will take an extended period of time thus increasing the time frame for the project and the possibility of increased escalation.



Q1 Have you (or those who live with you) visited any parks or recreation facilities offered by the City of Elyria in the past 2 years?










Q3 Which of these parks do you live closest to?







Q4 Please indicate how often you or people that live with you visited parks in Elyria within the past 2 years.






Q6 Have you or (or those who live with you) used recreation programs offered by the City of Elyria in the past 2 years?







Q8 How would you rate the quality of programs in which you or family members participated?









Q14 How would you like to hear about Elyria's programs and special events?






Q15 Do you live in the City of Elyria?


Q16 Counting yourself, how many people in your household are of the following ages?


Survey Summary

- When asked "What is missing in South Elyria?" most respondents indicated: "Youth Programming", "Trees", "Art", or "Community Involvement"


South Elyria Pocket Park - Survey Feedback Summary




When asked "What equipment would you like to see at the permanent pocket park?"








What uses of the pocket park would you like to see? 27 responses




How safe do you feel living in South Elyria? 27 responses

LOT Community Solutions Think Tank - Quick Facts

From Nov 2021- April 2022 Leaders of Today conducted a survey to gather input on the needs and desires of the South Elyria community about the construction of a pocket park. Below are the major findings of the survey from 118 respondents.

- 71 total respondents where 60% either live, work, or visit South Elyria.
- The ages of respondents ranged from 19 yrs to 61+ years old. The majority of respondents were 61+ years old.
- We found that the majority of people want a play area for children, an area to walk, benches, a shaded pavilion, and open green space.
- Some potential programming the community wants to see is walking/exercising, active
 play areas for children, and a fresh farmers market in conjunction with the community
 garden.

Walkability and Park Access maps - LCPH data

During the Think Tank, students met with representatives from Lorain County Public Health where they discussed walkability and park access in South Elyria. While South Elyria is walkable, park access (within a 10 minute walk) is limited.

South Rec is nearby, but without proper crosswalks it is unsafe for people to walk to the park which may be the only option due to lack of transportation.

Walk Audit findings

Students conducted a walk audit of the empty lot on the corner of 15th Street and West Avenue and recorded the following.

Sidewalks:

- Cracks in the sidewalk cause potential tripping hazards.
- . Unlevel and narrow sidewalks causing people to walk on the streets.

Street Safety:

- · No pedestrian signals at crosswalks.
- Distracted drivers
- Lack of street lights

Comfort:

· Not enough natural shade or tree canopies and no benches/places to rest
