1. CALL TO ORDER:

The regular meeting of Elyria City Council was called to order on March 6, 2023 at 7:02 p.m. by President Stewart. President Stewart opened the meeting with a moment of reflection, followed by the Pledge of Allegiance led by Mr. Tollett.

5. REMARKS AND REPORTS OF CITY OFFICIALS:

Asst. Safety Service Director Calvert:

ASSD Calvert provided an update on the progress of Forge 417, also known as the Esports Arena. The interior demolition began. The next steps would be presented at the next Planning Commission meeting. Consideration of a lot consolidation would be presented, due to five to six parcels that need to be combined. The phase following lot consolidation would be building, that is scheduled for springtime. A financial closing date is scheduled for the end of June or early July. Council member Tollett inquired when the TIFF would be expected? Ms. Calvert responded relatively soon. Ms. Calvert explained school board notification and chain of title will be required as well. Council member Davis stated that in the last 417 Esports meeting a construction in progress sign was requested. Ms. Davis asked Director Calvert if the sign was forthcoming? Director Calvert shared that a sign would be put in place at the time of financial closing.

Finance Director Pileski:

Finance Director Pileski reported that the independent auditors have started the audit for fiscal year 2022. The auditors will be conducting the audit over the next six months in house and by electronic file transfer.

5. REMARKS AND REPORTS OF CITY OFFICIALS: CONTINUED

Safety Service Director Lundy:

SSD Lundy explained that the Elyria Police Department experienced a major power outage on Saturday March 4th around two a.m. He provided employee recognition to Brett Schneider, Josh Sauers, and Bill Madden, who collectively were able to locate a part out of the county, travel to pick it up and work tirelessly to restore power to the police station. In addition, due to high winds, fencing in the area of Washington and Broad was in need of repair. Preston Curtiss and Keenan Williams from the street department were able to quickly send crews out to get the fencing back in place. Assistance with the fence required heavy equipment, Director Lundy also thanked Dave Rothgery, who was able to assist with the heavy equipment. Crews were called out at 8:30 p.m. as well for a major pothole on Cleveland St. Director Lundy expressed that crews responded quickly and came in without hesitation. Director Lundy provided an update to the status of the roof at the Elyria Police Department. He also shared that the safety service department receives quite a bit of calls regarding garbage cans not being returned to the property and left out at the curb. The safety service department has started sending letters out to owners of rental properties and tagging cans. Council member Oswald shared a strong opinion regarding tenants that leave their garbage cans on the curb as well as potholes not being repaired. Council President Mitchell, shared that the street department is always very responsive to pothole calls, she encouraged Mr. Oswald to call right away should he have issue or need assistance with a pothole repair. Council member Davis, explained that the enforcement of tagging and fining residents that did not have trash cans removed from the curb lawn by 5p.m. the day after trash pick-up has become relaxed. Ms. Davis expressed she hopes that the departments can get back to enforcing the legislation of removing the can from the property. Director Lundy responded safety service will tag, send letters then fine residents for cans left at the curb lawn.

Safety Service Director Williams: No report

Police Chief Pelko:

Chief Pelko stated that he would like to commend Brett Schneider, Josh Sauers and Bill Madden as well. He stated that the police department actually lost power Friday evening at 7:30p.m. and the team went in immediately. They worked until 3:00 a.m. to uncover the issue and was back at 7:00 a.m. to prepare for travel to get the part, install it and had the power restored by noon. Chief Pelko invited everyone to council chambers on March 13th at 3:00 for the swearing-in ceremony of five new officers. Chief Pelko also invited everyone on March 15th to the wreath laying ceremony for James Kerstetter Memorial noon at the Elyria Police Station.

Engineer McKillips:

Engineer McKillips provided an update to lane closures on East Bridge St. that will begin Monday March 13th as part of the big sewer project. Council member Oswald if a slow down sign could be placed near the GetGo gas station. Council member Cerra asked for clarification of the traffic pattern underneath the bridge.

WWPC Superintendent Korzan:

Superintendent Korzan explained that WWPC had been busy with permit requirements and CD deadlines along with the engineering department. The WWPC Plant had been busy with rain events. Supt. Korzan expressed on behalf of himself and his staff his appreciation of council for having all of their capital put into the temporary budget this year. It allowed the WWPCP to order everything they needed to order and get ahead of price increases. The WWPCP is a couple of months ahead of the game and looking forward to a successful year. Council member Tollett expressed that Superintendent Korzan made it easy for council. He explained that Superintendent Korzan provided several pieces of equipment that he placed trade in values for a year in advance. That process saved the taxpayers a tremendous amount of money.

Tiffani Reedy 113 Williams Street, Elyria- Republic Steel Quarry - Exhibit "A" attached, questions were asked of Superintendent Korzan who responded that the initial purchase of the Quarry from the city was park land and later found it to be contaminated. U S. EPA tested the waters and determined that the deepest portion of the water down to thirty feet holds the contamination. Soil was removed and the final remediation de-listed the quarry from the contamination listing. Every five years the quarry is re-assessed by way of a pubic hearing and no-one shows up. Council member Mitchell confirmed that fencing exists around the quarry. Council member Davis asked would it be possible to get together to visit the quarry. Cristini Johnson-Howard asked if she could address council and inquired to Superintendent Korzan regarding the flow of water and air. Superintendent Korzan explained there is no documentation from the EPA that determines there to be any concern with the flow of water. There is a town hall scheduled for March 25th at 2:00PM, location to be determined.

To City Council and the Administration,

Ms. Siwierka and I appreciate this opportunity to address the issue regarding the expansion of retail services at Chestnut Commons. As two lifelong Elyrians, with families that have seen Elyria change over the years, we see these developments with excitement, but also trepidation.

The tract of land for this development falls within the Third Ward, as well as Eaton Township, and the traffic corridor passes through the First Ward. This is why Mary and I wanted to express our thoughts and concerns as you consider giving the green light to this expansion. Let us be clear: we agree that expansion can be good for the city, but not if that expansion adds to the congestion that we're already dealing with around Chestnut Commons.

Phase one, bringing a gas station and grocery store, will, by the very nature of those enterprises, increase the amount of traffic on Route 57, as well as Chestnut Ridge. Additionally, we will see more traffic on Reasar Pointe Crossing. That area will also be ripe for expansion, and already has the infrastructure in place, which could bring several more businesses to the First Ward.

Now, it appears that Council is willing to give the developers the go-ahead without a solid plan for traffic control in place. It also appears that ODOT's involvement in this process won't begin until we're further down the road, no pun intended. The reality of the timeline, presented to Committee on Monday, February 27th, shows us that ABC Development doesn't offer a traffic-easing solution until 2026 or later.

So, if Council moves forward, and the Mayor gives his approval as well, we urge those parties to continue to challenge ABC Development for solutions and require ODOT to be at the table for future roadway design and development. We need them to be more than just silent partners in this process.

On behalf of myself, and Mary Siwierka, who couldn't be here this evening, we urge all parties to seek solutions, large and small, that will benefit the residents, and bring progress to our community.

Speaking of the community, it is vital that we the people be informed and engaged, as we will be part of the solution. After all, in the end, the consumers will determine the success or failure of these endeavors. We want them to be successful, without a doubt, and creating an efficient traffic situation is vital to that success.
