April 17, 2023 Regular Council Meeting Elyria City Council

### 1. CALL TO ORDER:

The regular meeting of Elyria City Council was called to order on April 17, 2023 at 7:01 p.m. by President Srewart. President Stewart opened the meeting with a moment of reflection, followed by the Pledge of Allegiance led by Council member Tollett.

### 2. ROLL CALL: COUNCIL MEMBERS

Mr. Cerra moved, Mr. Schneider seconded to approve the Regular Meeting Minutes of the April 3, 2023 council meeting as circulated.

### 5. REMARKS AND REPORTS OF CITY OFFICIALS:

### Mayor Whitfield:

Mayor Whitfield shared a follow up from a few weeks ago regarding major investments needed in the city. He shared discussion of a process that engaged residents in terms of getting feedback of what residents desire to have as city services, programs and amenities. Some of the ideas he would like to explore includes: a Central maintenance garage complex training facility, Southeast side of town fire station (satellite for police and fire), a fire truck (was already approved), rebuilding of pools, evidence building for EPD, Oakwood roof and windows, downtown facade rehab program, increase in the home beautification program, community violence prevention, senior utility relief program, sanitation trucks, road resurfacing, parks master plan and downtown lighting and cameras. The recommendation would be some ARPA funding, some Issue six and some water. A referral was made from the floor for a discussion of all of the above items in an upcoming committee meeting. A joint referral was confirmed by President Stewart to community development and finance committees for the next meeting date of April 24, 2023.

### **Safety Service Director Lundy:**

SSD Lundy advised that upcoming spring cleaning will be underway next week Monday April 24<sup>th</sup> and Thursday April 26<sup>th</sup>. Clean up crews will be launched in the downtown area, divided into two groups starting near municipal court working east, another starting at Dollar General and working west. Crews will clean sides streets, Kerstetter Way, Washington Ave., down near

railroad overpasses and onto the square. Crews will launch at 5:00AM and will work from 5:00AM to 7:00AM. Employees from streets, parks and cemetery will perform the cleanup weekly through September. SSD Lundy thanked all department heads who participated in the city job fair that was held on Friday April, 14th. SSD Lundy expressed his appreciation to HR Director Yousefi and SSD Williams for facilitating the job fair.

### Finance Director Pileski: No report

Council member Lipian asked if Finance Director Pileski could offer an explanation to letters residents have received from NOPEC that auto-ops them in for gas and electric service. Residents would like to know why they are being auto-opted in for service. Council member Tollett explained that NOPEC provides every resident the option to choose their gas and electric suppliers. Every resident has the option to make an apples to apples comparison of rates on the state of Ohio website, by typing in gas and electric apples to apples. Council member Tollett explained that when utilities were deregulated, the selection process requires extreme care not to select a variable rate. First Energy has announced that electric is likely to double due to pending litigation. Council member Tollett provided a recommendation to shop First Energy and select a carrier for service prior to June 1<sup>st</sup>, 2023. SSD Lundy shared that he would like to have NOPEC come and share the specifics of the program. Council member Mitchell explained the importance of understanding, that if residents are not interested in NOPEC, they must opt-out. The options for opting out, are to make a phone call or submit the correspondence received in the mail. Law Director Deery explained the city of Elyria is a NOPEC community.

### Law Director Deery: No report

### Police Chief Pelko:

Chief Pelko provided an update to the helicoptor that was flying overhead the past weekend. He explained that Elyria Police in collaboration with Ohio State Patrol conducted a saturated patrol event on Thursday and Friday. Some of the higher crime areas of the city were targeted. Eightyfour contacts with citizens were made, six arrests: three drug related, one fire arm related and twenty-nine verbal warnings. Chief Pelko felt the event as a success and plans for additional collaborated events in the future. Council member Oswald inquired if any cost was associated. Chief Pelko responded only cost associated was to the officers in overtime hours. Chief Pelko reported that 1825 Lorain Blvd, Days Inn was condemned, squatters were found living in the building. May 1<sup>st</sup> a traffic detail will begin at the police department, officers will be assigned specifically to traffic patrol throughout the city. Officer Rick Walker will be retiring April 28th after thirty years of service. A celebration will be held at 12:00 noon on April 28th, all are welcome. Chief Pelko made two referrals from the floor: The matter of purchasing up to twentyfive more body cameras and licenses, the matter of applying for and accepting the project safe neighborhood grant. Council member Mitchell expressed her excitement and appreciation with the traffic detail news. Council member Davis expressed her excitement with the news of the old Holiday Inn (Days Inn). Council member Cerra asked about foot patrol downtown. Council member Lipian congratulated Chief Pelko on the apprehension of the Cambridge shooter and Officer Brown for enforcing traffic patrol in the Eastern Heights area.

### 5. REMARKS AND REPORTS OF CITY OFFICIALS: CONTINUED Fire Chief Pronesti:

Chief Pronesti shared good news in regard to a group of Girl scouts that was able to tour the fire station. During the covid pandemic, hours had to be suspended, however all are welcome to tour once again. Chief Pronesti shared that the fire department experienced another fatal fire on Easter Sunday. He shared the fire was extremely intense due to the construction of the house, which is a balloon frame old legacy style construction. Chief Pronesti explained the style of construction, means there were no fire stops and it was difficult for fire crews to get in and conduct a search. Chief Pronesti expressed the importance of a smoke detector program that he spoke with Mayor Whitfield about implementing. Chief Pronesti explained there have been eight fatal fires since 2021, most did not have smoke detectors installed. Chief Pronesti provided a reminder regarding safety precautions in Cascade Park. He shared that he has an unplanned employee that will be retiring from the fire department. He provided an update on the staffing issues with Lorain county 911 and EMA. The 911 director was let go and the EMA director quit, no communication was disseminated to the fire chiefs. Mr. Cerra asked Chief Pronesti about a birth. Chief Pronesti shared that the fire department delivered a baby boy by emergency delivery. Recognition for the firefighters involved will be given. Council member Oswald inquired about the fire departments's knowledge of balloon frame construction. Chief Pronesti explained he and his team are well versed in balloon frame dwellings due to Elyria being known as a legacy city.

### **Asst. Safety Service Director Calvert:**

ASSD Calvert provided an additional reminder regarding the comprehensive plan. The survey remains open for feedback at our lyria.com. A workbook was submitted to city council members requesting feedback. The survey will be closing in the next few weeks. The next step will be an existing conditions report that will be presented to the steering committee. The existing conditions report will be incorporated with the survey data.

### **Safety Service Director Williams:**

SSD Williams introduced consultants McCauley & Company, per request they will provide quarterly reports to council. McCauley & Company are responsible for grant acquisitions with the City of Elyria and have been successful in supporting the city of Elyria. The latest grant awarded is in collaboration with the city of Lorain and the Lorain County Urban League for violence prevention.

Justin McCauley- 19660 Rosalind Dr. Rocky River, 44116- Mr. McCauley introduced members of his team that joined him at the meeting, Shannon Strachan and Sean Lowe. Ms. Strachan shared that bi-monthly meetings are conducted with the administration and several meetings throughout the month with staff. The grants submitted have been, two AFG grants, one for radios, one for a rescue truck, safe routes to school and an OEPA leaf vacuum grant. A couple of the awarded grants include the community violence reduction grant, TlCI implementation, bike helmet, ARPA First responder wellness program, Safe Streets for All, through the Lorain County Public Health, Nature works and Nord Family Foundation grant. Ms. Strachan stated that some grants they continue to work on include a CMAQ grant in collaboration with NOACA, an EECBG grant, NOPEC nec grants, water, cop's hiring, and fire training grants. President Stewart

inquired about the communication with the city departments. Ms. Strachan explained that grants are reviewed weekly at the state and federal levels, submitted to the city of Elyria administration, Administration submits to appropriate staff members, McCauley then follows up with the Elyria staff members. Council member Lipian asked if ODOT had voted on the safe routes to school grant. He shared that Representative Manning stated that she would write a letter in support of the grant. Mr. Lowe explained that McCauley represents the city in a government relations capacity, representing the city to state officials and federal government. In February, McCauley arranged a meeting with J.D. Vance's Northeast Ohio Director to meet with the city administration, to ensure the new Senator is familiar with the city of Elyria. McCauley and Company tracked the federal appropriations process, certain projects are earmarked for local governments and non-profits. Mr. Lowe explained with control of the house switching to Republican control, the earmark process posed some new challenges. The team was able to submit the southeast sewer interceptor extension project to Congressman Latta and Senator Sherrod Brown. Congressman Latta has moved the project to the next phase of deliberation. The next update would be anticipated in June, with the final budget passing in December. President Stewart requested a bulleted report of the items that were presented.

### **Engineer McKillips:**

Engineer McKillips congratulated council on compiling the 2023 street resurfacing list and getting additional funding. She expressed her appreciation to Engineer Schneider and Mr. Forthofer for their help as well with ride alongs and engineer bids. Cleveland Street project water line work is two weeks from completion. East side relief sewer project is moving along slowly, currently waiting for utilities on East Bridge Street. A big chamber will need to be built near East Bridge Street. On cityofelyria.org website, a link exist to traffic and construction map updates. Council member Cerra asked how long the delay may be. Engineer McKillips, explained she was not quite sure due to Windstream installation. Council member Cerra, asked if the delay with the project would affect the ODOT program along Cleveland Street and East Bridge Street. Engineer McKillips responded that could be a possibility. Council member Cerra inquired about the water main on Wesley. Engineer McKillips explained that they are currently reviewing the plans. Council member Mitchell thanked Mr. Schneider and Mr. Forthofer, she explained that even with the extra money received, more money is needed. Council member Lipian inquired about the East Broad Street project. Engineer McKillips explained the work would begin with underground work. Needs would be assessed for any traffic signals or poles. Engineer McKillips explained the traffic paving markers must be marked first to match the traffic signals. Council member Lipian requested to add the corner of Cornel and Fairlawn as an alternate to the street list as well. Council member Lipian asked about the train dividers near Prospect. Engineer McKillips explained the guiet zone has not been established yet, more paperwork is required.

### **Building Official Farkas:**

Building official Farkas shared that Journey Inn located on the corner of Lorain Blvd. and Bell Ave. has been boarded up due to safety concerns. A condemnation notice was issued due to faulty electric. Building Officials accompanied EPD to Days Inn, the building was found to be in

deplorable conditions. Squatters were found in the building along with a gas generator. Mr. Farkas explained that his department, along with the fire department will submit a report for condemnation or recommendation of demolition of Days Inn as well. Mr. Farkas shared good news in that they had an applicant apply to the plumbing inspector position from the job fair. A position with the building department for a Deputy Housing Inspector will be posted next week. Council member Davis inquired on the security of the windows at the Days Inn building, and shared that Mr. Farkas could explain to her off record. Mr. Farkas explained all areas of damage would be secured throughout the building. Council member Mitchell explained that she receives multiple calls regarding windmill pieces at the old Moen building. Mr. Farkas explained their has been no cooperation with the owners of the building. Council member Lipian asked about the Friendly's building, inside is molded and infested with animals. Council member Lipian expressed concern that the building would not sell in the condition that it's in. Mr. Farkas, explained that the building department does not have right of entry to the building. Council member Lipian inquired about the road near DIY Auto Parts and McDonalds, however not certain of the name of the road. Mr. Farkas requested confirmation regarding if the road is public or private and if a complaint had been lodge with the building department. Council member Lipian explained that is a private road. Council member Simmons asked about the monstrosity of the commercial building that sits across from the Wilkes Villa complex. Mr. Farkas explained that building is currently caught up in the court process.

### **WWPC Superintendent Korzan:**

Superintendent Korzan shared that on Saturday April 8<sup>th</sup>, the WWPC team received a call regarding a report of twelve trash bags in the river, just downstream of Mussey Ave. bridge. The bags were removed and determined that it was brush in the bags. The team, led by Christopher Werling, consisted of Stephen Loesch, Alexander Deaton and Tyler Huge are proof of the exceptional staff that is committed to protect public health and the environment. Superintendent Korzan made a public service announcement to secure items if you live along the river bank, items tend to be picked up by the water when the river is high and floating down the river. Council member Lipian asked about residents opting in for a lateral line. Superintendent Korzan explained that he is finalizing the quarry report and will have the opportunity to complete the paperwork in the next week.

### P & R Dir. Reardon:

Director Reardon shared that the parks department is hiring, lifeguard, concessions, swim instructors, pool managers and camp counselors. Some applicants were identified from the job fair. North Park parking lot paving is just about completed. West Park walking trail has started. The process is to complete the trail, Lowell St. parking lot and then pickle ball courts. Washington Village will be completed after the pickle ball court. Registration for swim lessons will begin May 2<sup>nd</sup>. Saturday May 20<sup>th</sup> is Lorain County Beautification Day. A request for projects in your neighborhood or area throughout the city is being extended. Please call the parks department, please call to volunteer as well. May 4<sup>th</sup> will start food truck Thursdays in the square. Council member Tollett congratulated Ms. Reardon and Mr. Horwedel for the opening of the dog
