The proposed Tax Budget indicates the estimated revenues, estimated unencumbered balances and estimated expenditures for the year 2024.

### President Stewart asked if there were any proponents?

Ted Pileski-131 Court Street, Elyria, OH 44035 - Finance Director Pileski shared that the tax budget is a document that is required by state law to be passed annually and filed with the Lorain County Budget Commission. The request for consideration presented before council was the 2024 Tax Budget. The budget begins with an estimated cash for each fund by fund type, estimated revenues and expenses to come in for 2024, and estimated cash for the end of 2024. Finance Director Pileski explained that at the completion of the year, he would amend the document with the budget commission to replace estimated cash with actual cash on hand by fund type. Estimated revenues are amended as they are received or not received throughout the course of the year. Finance Director Pileski requested approval to file the tax document with the Lorain County Budget Commission.

Mayor Whitfield stated that in regard to the revenue projections that Finance Director Pileski spoke about, that he noticed during his time in office, an increase in the income tax revenue. Mayor Whitfield expressed he was aware of concern over the loss of Bendix and how the loss would impact the city of Elyria. He expressed appreciation for Ridge Tool, Duraline, Multi-Link and public partners such as the Lorain County Community College and the county government that have helped the city. Mayor Whitfield expressed his excitement with the projections.

### Dear Members of Elyria City Government

On January 19, 1999 Elyria City Council passed Ordinace 99-5 establishing two Bicycle Routes in the City from the Lorain County Metro Bike Path to the Black River Reservation Lorain County Metro Bike Trail and then Back again. Today those two locations are called the North Coast Inland Trail Gateway Trailhead and Bur Oak. If one searches "Bicycle Routes' on the City's website, the results are "No Results Found." It would not surprise me if many residents or even members of City Government are not even aware of these routes or their specifics, and yet they are part of our current code. This ordinance can, of course, be found on the American Legal Publishing Corporation website. This site, however, is only current through June 8, 2021.

As a 43 year resident of Elyria and one concerned with safety and the image of my home city, I am asking City Council to consider rescinding this ordinance for the following reasons:

- There are currently better, shorter, easier and most importantly safe ways for cyclists to travel from these two points, particularly on the Bridgeway Trail as established by the Lorain County Metro Parks. There is infrastructure that did exist in 1999 and there are better solutions to getting from point A to point B, particularly for those residents and visitors who do not know their way around Elyria.
- 2. I have surveyed both routes, North and South. Of the 54 Intersections with turns on the North and South routes, 25% of them have no signage indicating the route or a turn. Some other intersections have only one sign. With rare exceptions, intersections that go straight are not marked, which is not uncommon on marked routes of this nature. All turn intersections are designed to have an arrow and a Bicycle Route sign. Since the Route's inception, I have observed that the signage has not been kept current. Without proper signage, how is anyone not familiar with the area, with its bridges, rivers and railroads to know where to turn? Those who are familiar with Elyria likey do not need route signage. An example of the Route not being kept current is the past and current closing of Poplar St, and the fact that there has been no detour posted for the Bicycle Route.
- 3. The route goes through 2 privately owned properties, one on Washington Ave. and one on Poplar St. One parcel is the former Northwood Junior High, now owned by a private organization and the other is the parcel on the North Cul de Sac of Washington Ave. at 823 Washington Ave. An easement for this sidewalk and a water main is listed on this residential property on the Plat Map for this area. I am not able to determine whether or not any easement exists on the former Northwood School property.
- 4. The routes to and from Gulf Rd. and Hemlock Dr. to Bur Oak on Ford Rd. and back are in my opinion, the biggest concern. Although the speed limit on Gulf Rd. is 35 MPH, 50 MPH or higher is not uncommon and Gulf Rd. is heavily traveled. The Routes turn at the intersection of Gulf and Ford in the Village of Sheffield and this intersection is often congested as it is only 200 feet South of the intersection of Gulf and Detroit Rd.(Rt 254).

Ford Rd is a steep hill that is difficult to climb on a bicycle, particularly with motor traffic going both ways. Also, the vegetation on the East side of Ford going up the hill often encroached onto the roadway, effectively narrowing the roadway. All in all, I consider this Northernmost section of these Routes to be the most dangerous section of the Routes and to be generally unsafe for all but experienced cyclists. This section is, in my opinion, not appropriate to be part of a city's codified bike route that is intended for riders who do not know the way to a destination. Within the past 2 ½ weeks, there have been two accidents on the North section of Gulf Rd South of Ford Rd in Sheffield Village during the daytime causing considerable damage to the City of Elyria, Ohio Edison and our property at 1730 Gulf Rd.

5. This North section contrasts with sections on Abbe Rd. North and South of Rt. 57 which directs cyclists to go onto the sidewalk. The North Route directs cyclists to walk across Rt 57 WHERE THERE IS NOT A CROSSWALK. This is a serious safety concern particularly for youthful riders and I'm saddened to bring this to your attention.

The primary issue that I am bringing up is Safety. If the routes codified by the City of Elyria are unsafe and I believe they are, it is incumbent on the city to correct the situation. Period. Failure to do so, I believe creates a liability issue that the City of Elyria and all its residents can not afford. We can do better than this.

I would encourage any city official to actually ride these routes. This will give you firsthand knowledge and you'll be better able to assess my concerns. I am fully aware that this is not the most pressing issue facing Elyria of society, but I believe it is low hanging fruit that can be easily accomplished. It will remove an ordinance for which the original purpose no longer exists and will help make Elyria a safer place to live.

Additionally, I am willing to escort any city official on a bicycle ride on either of these two sections of the Bicycle Routes. I can't guarantee your safety, but will do my best to escort you in a safe manner. I've ridden this area many times and I'm always fully aware of my surroundings. Please contact me to make arrangements if you wish to take me up on my offer.
