

September 5, 2023 Regular Council Meeting Elyria City Council

1. CALL TO ORDER:

The regular meeting of Elyria City Council was called to order on September 5, 2023 at 7:00 p.m. by President Stewart. President Stewart opened the meeting requesting a moment of reflective silence, followed by the Pledge of Allegiance led by Council member Cerra.

Ms. Ardelia R. Tolbert-520 Bond Street.- Ms. Tolbert expressed concerns regarding the height of the building as well the age of the occupants of the building, considering the surrounding community is an older community.

Valerie France- 519 Bond Street- Ms. France expressed concerns regarding the project from her perspective being rushed. In addition she shared concerns regarding rainfall absorption and green

space once a new building is constructed. She is not in favor of disruption of the existing quiet community.

Joan Gardner - 600 Foster Ave. - Ms. Gardner expressed she is opposed to the entire idea of rezoning.

Thomas Boggs- 526 Foster Ave.- Mr. Boggs stated that he is simply against it.

President Stewart asked Building Official Farkas to address some of the concerns. Council member Davis stated that the project is in her ward and she would appreciate the opportunity for the company to meet with the residents to address their specific concerns and answer any questions that the community members may have. Asst. Law Director Breunig stated that the public hearing tonight could be declared a second reading if council decides not take action. Building Official Farkas addressed the concern of the height requirement. B.O. Farkas shared the current zoning code height requirement allowable is 35 feet, the new zoning code will allow a height requirement of 40 feet. In discussions with the builder, they will do their best to comply with the requirements. Questions of concern were posed during Planning Commission, regarding the aesthetic appeal. He expressed from his perspective the difference of 5 feet is not a whole lot, however depending on the roof design it could potentially be lower. B.O. Farkas stated that he could not speak to the grading concerns addressed, the Engineering department would need to address that concern. The rezoning would also require stricter set backs than the current zoning. The structure would be further away from the property line than the current zoning permits for a house. Council member Oswald inquired about water filtration and proper drainage due to a lot of water in the area. He asked if there were any planned safeguards in place. B.O. Farkas, stated that although he could not speak for the engineering department, he explained that there is a filtration process for plan submittal that includes review from the engineering department of the grading to ensure the yards are not raised too high to divert water. He is unaware of storm water laterals in the area.

President Stewart stated that he would request the administration and Council member Davis coordinate details of the community meeting for additional concerns to be addressed for residents.

The map reflected was a bing.com map. Mayor Whitfield stated this issue has been going on for quite sometime. He stated that if you were to pull up a google map and look up the Wilkes Villa housing complex, the area would reflect on the google map as Coonville. Mayor Whitfield shared information regarding the racist history of the name. Mayor Whitfield stated that he had made contact with google representatives. His belief is that it takes more than one person to advocate for a name change on a google map. President Stewart stated that we certainly need to take a proactive stance and confirm where the name originated from. President Stewart referred to Asst. Law Director Breunig for next steps. Asst. Law Director Breunig explained he had been unaware of the name reference on the map and the best route would be to gather additional information. Council member Tollett asked Mayor Whitfield in his research, would he happen to know if the maps are identified on wikipedia and is Mayor Whitfield aware of if the maps could be edited. Mayor Whitfield stated that he was not aware the reference was on a bing map as well as a google map. His research and reach out was to a civil








Engineering Update

09/05/2023

Street Resurfacing

The asphalt contractor has started manhole and catch basin casting adjustments on the street paved with asphalt. Please watch for construction cones and barrels on the newly paved streets.

The Concrete Street Repair contract is in the process of being awarded. This project was re-bid due to the bids coming in over 10% over the Engineer's Estimate. Due to the timing of the bid opening and award, part of the work will likely be performed in Spring 2024 (this work is weather dependent and allowing the contractor to perform part of the work in 2024 helped with the final cost of the contract). A schedule will be shared when we have one.

West Ave Watermain Improvements

This project about a couple weeks out from being wrapped up. Then, the resurfacing contractor will be in to get the new asphalt down. With the weather cooperates, West Ave work should be completed by the end of the first week in October.

ESRS

People are wondering what's going on with Gulf Road; why is the contractor working on the road and not the sidewalk; when will all the East Bridge lanes open back up.

This project has had its share of obstacles.

- Delay in delivery of the shoring system for the E Bridge Chamber.
- o Fiber/communication duct bank found to be in the excavation area of the chamber as well as electric pole and gas main encroachments
- Steel casing pipe found around the 10-foot storm sewer that needs to be cut for the chamber construction
- Old sandstone box culvert buried when the 10-foot storm sewer was installed.

- Concrete duct bank on Poplar that meanders in and out of the excavation for the 72" pipe.
- Normal everyday issues like finding additional inverts needed in a new manhole, trying to determine is an old utility is live or abandoned, etc.

So, to answer the common questions:

- 1. Work on Gulf Road will continue when the chamber hole in front of Smitty's and BP is backfilled and pipe is in place on East Bridge. Gulf Road is also being used for a staging area for pipe, materials and equipment. The general area just isn't suited for having a large enough construction yard to store the size pipes involved on this project.
- 2. On Poplar, it's important to be able to move traffic as soon as possible so work was concentrated on the roadway and not the sidewalks. The sidewalk work will take place after drive approaches are completed.
- 3. Work on East Bridge should be wrapping up the beginning of November if no hurdles are encountered.

E Broad Street project

Work continues on E Broad Street. The road is closed between E. River and Park. This is a short-term closure. Traffic updates are being sent out when changes occur.

Cleveland St Roadway Project

As of last Friday, the contractor will be out on site after Labor Day to perform test holes and locate the new traffic signal poles spots. The work zone will be installed. Curb removal on the south side of the street is expected to begin on 9/13 if everything falls into place. Traffic will be limited to 1 lane in each direction until the first part of November when the contractor needs to have all 4 lanes opened to traffic.




Patrol Officer Mic Fairbanks retired on Sept. 1 after 25 years of service.

Wastewater Department – Report to Council

September 6, 2023

Topic: Recent Rain Events

August 11, 2023:

On this date, the City of Elyria received 2 inches of rain over a very short period of time. Several times during the rain event, the rain was falling at rates of 3-4 inches per hour. Neither the sanitary or storm sewers were able to keep up with the rates of rainfall. There were 11 calls for service due to basement backups and 4 calls for service due to water ponding in the streets. Wastewater crews were dispatched and responded to each call for service as they were received.

August 23, 2023:

On this date, the City of Elyria (and all of Lorain County and Northern Ohio) experienced the worst storm event in decades. The National Weather Service classified this as a 500-year storm event. The only other storm event in recollection that was similar to this was the July 4, 1969 storm/flood. In comparing the amounts of rainfall to Elyria for both storms, the storm of August 23rd was worse than the 1969 storm at 6-7 inches of rain for this most recent storm compared with 4-5 inches recorded by the National Weather Service for the 1969 storm. We are recording this storm in the 6-7 inch range because we lost power to the rain gauge when it was reading 6.5 inches while heavy rain continued. While we are certain the total rainfall exceeded 7 inches, we can only officially record 6-7 inches for the event.

At approximately 3 PM on August 23rd, Elyria received 2 inches of rain over a very short period of time which sent the flow rate coming into the wastewater treatment plant from 5 million gallons per day (MGD) to 75 MGD (please see the first attachment). This first storm saturated the ground and filled the sewer systems to capacity. A short time later, before the systems had a chance to catch up, additional storm supercells kept forming one after another on into the night dropping an additional 4-5 inches of rain. This completely overwhelmed the storm and sanitary sewers and the wastewater treatment plant. The flow rate coming into the treatment plant far exceeded 100 MGD, which submerged plant processes and caused bypasses through the processes to the river. As per our NPDES permit, Ohio EPA was notified of the bypasses and a public notification email was sent out. The only previous time the treatment plant sustained any flooding was during the storm on July 4, 1969.

There were 82 calls for service due to basement backups and 25 calls for service due to water ponding in the streets. The East side of the city was most affected with backup issues, with the highest concentration in the Abbe Road North area (please refer to the second attachment). Wastewater crews were out all night and through the next day responding to these calls for service as they were received. Additional crews were in keeping the plant operational and taking care of the flooding issues there.

The third attachment is a table of all significant rain events from 1995 through 2023, to date. While those highlighted yellow indicate the largest, many of the events in the 1-2 inches of rain column occurred over very short periods of time and cannot be discounted as significant events. It is important to note that there are only two storms in the 6-7 inch categories: The first was caused by Hurricane Sandy from October 27 - 31, 2012 which dropped 7.17 inches of rain over a 5-day period. The second was the August 23, 2023 storm which dropped 6-7 inches of rain over a period of 12 hours.

There were most probably a number of residents who had backup issues but did not call the wastewater plant at (440) 366-2211 Ext. 0 to report the problem. We have Operators on duty 24/7 to receive such calls and dispatch crews to investigate the problem. Our crews can also provide follow-up services and information to assist residents with these issues. The City Engineer's Office also has lateral replacement and backflow/check valve installation programs to assist residents who might want to look at these options as ways to help prevent future backups. 




WWPCP Rain Event Map




