Law Director Deery:

Law Director Deery brought to the attention of council an ordinance that required n amendment. The ordinance was passed June 2023 to authorize the community housing impact and preservation funds. HUD requested necessary language be added, which led to the amendment and request for emergency with the legislation. Request for passage without the benefit of a committee report, suspension of rules and declaring an emergency.

Engineer McKillips provided an update to the Cleveland Street Road diet project, in that it is near the end. The East Broad Street project will run through the winter months with underground work. The East Side Sewer Relief project had challenges with rock excavation. Harwood sewers should be installed within the next month. Council member Oswald inquired of the possibility of an easier travel once the Lafayette and Gulf Rd. project meets. Engineer McKillips responded yes and stated the closure would meet at Gulf rd. and Ohio Street. Engineer McKillips is hopeful all pipes would be installed underground by March.
