# 5. REMARKS AND REPORTS OF CITY OFFICIALS:

### Mayor:

Mayor Brubaker provided an update a ribbon cutting he attended on Saturday May 3<sup>rd</sup>, at a new business located at 403 Cleveland Street, The Inspiration Room. Located in the same plaza as Dale's Cozzeria. The business has several vendors and a small coffee bar. Mayor Brubaker encouraged residents to stop in to see what the business has to offer. Mayor Brubaker spent the earlier part of his Monday with the Lorain County Chamber President, Tony Gallo at the ribbon cutting of the new sports zone center at 221 Gulf Rd, across from American Legion. The owner is Wayne Fitzpatrick, the building is a production, podcast, radio studio which provides office space and conference rooms. The business is in collaboration with Buckeye Community Bank. Mayor Brubaker shared that the upcoming Saturday, May 10<sup>th</sup>, Expresso Bakery will have a ribbon cutting for the new owners of the bakery.

Council member Siwierka inquired about the food truck in the parking lot of the MAC Pharmacy located at 710 Cleveland Street. Council member Siwierka expressed concern regarding if the food truck was temporary and how many additional food trucks would "pop- up" around the city. Mayor Brubaker responded the food trucks would be inspected by the fire department to ensure they are certified by the state and inspected by the health department. Mayor Brubaker stated that he would follow up with Assistant Fire Chief Gall, ASSD Loesch and Building Inspector Farkas.

### Law Director Deery:

Law Director Deery provided an update that the common pleas court has officially appointed receivership for the former Days Inn property. The bond and oath have been submitted. There has been a walkthrough of the property and the receiver had the opportunity to see the inside of the building. The receiver will move forward with abating the property the best way he sees fit and report back to the court. City officials participated in the walk through as well. Security was present as the need existed due to vandalism. The building still has some unauthorized accessibility areas. There was discussion regarding the need for fencing for safety purposes as well as the need to maintain what is left of the integrity of the property. Law Director Deery will continue to provide updates as they arise.

Council member Schneider inquired if the property taxes are current on the property? Law Director Deery stated they were during the last inquiry.

Council member Davis asked if a timeframe was provided with information regarding the plans for the property? Safety Service Director Pyanowski explained two possibilities are being explored, one is renovation, the other is demolition.

Council member Siwierka asked if the receiver was surprised of the condition of the property? SSD Pyanowski, explained it was hard to read his reaction, however he believed that he was able to get a perspective of what had previously been shared with him regarding the condition of the building.

Chief Pronesti stated that he had no report, however he wanted to provide an update on the food truck vendor at 710 Cleveland Street. Fire Inspector Lenowski, from the fire prevention bureau, inspected the food truck and it passed inspection. There would be no other items from the fire prevention bureau perspective that the vendor would need to provide. The vendor permit is seasonal.

#### Eng. Schneider:

Engineer Schneider provided an update on the concrete portion of the resurfacing project from 2024 and explained the contractors are wrapping up the project. Hawthorne is the last street to be poured. May 6<sup>th</sup> the milling of West Ridge Road will begin. The milling will take three days, the overall project should be completed in four weeks.

Council member Mitchell inquired about the 2025 street resurfacing ranking and pricing. Engineer Schneider stated he would have the ranking finalized by May 6<sup>th</sup>, some of the pricing is started and the remaining should be completed by Wednesday May 7<sup>th</sup>. He explained some
