#### **ITEM NO. 1 – RFI #5**

- A. **Question:** Requesting clarification regarding the specified fire alarm system. Will this FACP be part of a larger FA network or will the "network" be comprised of the Main Bldg and Police Bldg only?
- B. **Response:** The Fire Alarm "Network" will be comprised only of the Fire Alarm Control Panels (FACPs) located in the Maintenance Building and the Police Storage Buildings.

# <u>ITEM NO. 2 – RFI #6</u>

- A. **Question:** 2.02 Command Center Integration. Is there an existing IMS system for an existing FA network? Can you share the number of nodes on the network that would need to be modified on the existing network?
- B. **Response:** There is no existing system or existing command center. A new command center will not be created nor will one be required for these new buildings.
