Mayor:

Mayor Brubaker provided an update on the completion of the chip and seal process of Fowl Road in collaboration with the County Engineer's office. Mayor Brubaker expressed his appreciation to SSD Strohsack, the street department and County Engineer for their hard work and stated the road looks great. Mayor Brubaker introduced the shops on Broad Street and shared with council members he had the opportunity earlier in the day to participate in the ribbon cutting of one of the businesses, Roxie's Emporium. Three other businesses will open soon as well to include Kreations by Kianga. Kreations by Kianga was the first business as part of the incubator space in the city hall building until downtown space could be located for ongoing business. On Tuesday September 16th at two o'clock will be the kick-off of Forge 417 E-Sports. Mayor Brubaker expressed his excitement of all the things happening in downtown Elyria.

Finance Director: No Report

Law Director Deery:

Law Director Deery welcomed Councilmember Lipian back to council. Law Director Deery provided councilmembers with an update to an amendment to the economic development agreement for DBR Commercial Realty that was signed the week of September 8th and forwarded appropriately.

Council member Siwierka inquired if there were any new updates on the Holiday Inn receivership? Law Director Deery provided an update that the application that was submitted to have the property declared as a historic landmark had been tabled at least through December.

5. REMARKS AND REPORTS OF CITY OFFICIALS: Continued EFD: No Report

Chief Pronesti responded to the question from Council member Oswald. He shared there has been an uptick in calls in that area of unresponsive persons, who are homeless. He expressed the concern within the fire department and fire prevention bureau is that if a fire happens, there will most likely be homeless persons n the building. Chief Pronesti stated the Elyria Fire fighters will have to risk their lives in the most deplorable building he would describe in thirty- seven years. Council member Oswald commented that the Cedar Street fire station repairs look very nice. Chief Pronesti expressed his appreciation to the administration for the needed repairs. Council member Siwierka asked in SSD Pyanowski absence if there was an update to the EMS Study. Chief Pronesti shared the entire report had not been received. The portion that has been received, has been GIS, mapping and data. Council member Siwierka requested a deadline date of the report. Chief Pronesti stated he believed the deadline is October 10, 2025.

Eng. Schneider: No Report

Council member Siwierka shared a concern of an issue with a left turn visibility onto Chestnut Ridge into Aldi's that would require some attention along with the traffic study in the Chestnut Ridge Road area.

Council Member Schneider inquired about a road sign off of Reaser Point Crossing, Weston Way, he inquired if the project is a permanent project or an access point for a construction project. In addition, he inquired about a follow-up question to a previous concern regarding, no right turn on Hilliard and Abbe Rd. due to Northwood pedestrian traffic. Engineer Schneider explained the driveway to Weston Way is a driveway to the water tower. The existing driveway comes off of the Wal-Mart property, Water Distribution is putting in a drive to make accessibility more feasible for service vehicles. The Hilliard concern was investigated and the recommendation is to install a no turn on red during school hours only sign.

Council member Mitchell inquired on the status of the residential street repaving. Engineer

Schneider explained they are awaiting a start date from the contractor.

Council member Lipian requested a follow-up of completion date for Ward One streets.

HR Dir. Yousefi:

Director Yousefi provided an update of a preliminary Gallagher Salary Study. She shared the final report is anticipated to be available by the end of October 2025. The new salary structure has been established which collapses the current thirty-seven ranges to a more manageable sixteen ranges. The steps remain the same at zero to twelve. The results reflect a mix of some jobs below market, some above and many that are in line with the market. All of the jobs benchmarked are earning within 15% of the market median. Five positions were low enough to warrant an increase to a higher level. The final report will provide recommendations for keeping the payrates relevant in the market as well as a methodology for moving employees through those steps.

Council member Siwierka asked about an update on a list of trainings that were budgeted for the year. Ms. Yousefi explained that line items had not been appropriated, however she worked with the finance team to get in in line. Some of the trainings scheduled were Leadership Lorain County, DEI Committee, and Manager trainings.

I AM HERE TO VOICE MY CONSERVES about Lourseing the flag
FOR CHARLIE KIRK ON PUBLIC BULLDINGS

My name is Anne Swabb, and I am the parent of a U.S. Naval Academy graduate, now a commissioned officer. My family has served this country, and I take pride in the values of honor, sacrifice, and respect. That is why I am deeply concerned and disappointed that Elyria recently lowered its flags to half-staff in honor of Charlie Kirk.

Lowering the flag is traditionally reserved for public servants, local heroes, or moments of national tragedy. Extending this honor to a political commentator whose rhetoric has targeted marginalized groups does not reflect the inclusive values Elyria should stand for.

As a woman, I have felt my rights stripped away. I had more rights as a teenager at Elyria High in 1989 than I do now, at age 54, living in Ohio in 2025. My experience is only a glimpse of what people of color, LGBTQ+ individuals, and immigrants have long endured.

I understand that Governor DeWine issued the order. However, Elyria's leaders still have a duty to reflect the values of their citizens. If the city takes issue with such orders in the future, I urge you to please "run your concerns up the flagpole" with the state, so our community's voice is heard and ALL citizens are protected.

Our flags should represent unity, sacrifice, and respect for all. Honoring a man who opposed inclusivity turns our backs on the very people democracy must protect. I respectfully ask you to reconsider the message Elyria is sending. Our community deserves symbols that uplift us all, not symbols that divide and diminish.
