3. The matter of a rezoning request for parcel #06-24-003-104-096, Brunswick Dr., from R-MHL Residential-Multi Household Low Density to R-MHH Residential-Multi Household High Density.

Referred By: Builders & Developers Co., Inc.

[This matter was passed by Planning Commission on 10/14/2025 with no conditions].

This rezoning request will be discussed by the applicant; Rich Beran, 37201 Royalton Road, Columbia Station. They are asking for half of the parcel which is the western half to be rezoned from R-MHL to R-MHH. The balance of the site is already zoned R-MHH. The site total is 9.6 acres and they are proposing to build 23 buildings with 4 units in each. Each unit will have its own entrance door. Each building will be single story. The sanitary sewer is on Brunswick Dr., the water is available on both Brunswick and West Ridge. The site plan calls for an on-site water detention. There is further information regarding set-backs, dumpsters, building height and they were approved. There are four items that will require a variance and can be done by going through the variance requirements. The variance requirements are for the distance between buildings, size of parking areas and items regarding the signs and number of signs, concrete bumpers and curbs. They've applied to the Board of Zoning for those items.

Chair Schneider asked if this is one complex of apartment rentals? Mr. Beran said yes. And the buildings do not connect.

Mrs. Siwierka said they look similar to the apartments on S Abbe.

Chair Schneider read the committee report and asked for a motion.

Motion was made by Mr. Lipian and second by Mrs. Mitchell authorizing the 'said' rezoning request.
